

DESCRIPTION

The MiniLED has been designed to meet the increasing demand for white SMD LEDs. The feature of the device is the very small package 2.2 mm x 1.3 mm x 1.4 mm. The MiniLED is an obvious solution for small-scale, high-power products that are expected to work reliably in an arduous environment. This is often the case in automotive and industrial application of course.






Figure 1. Forward Current vs. Ambient Temperature




Figure 2. Relative Luminous Intensity vs. Forward Current




Figure 3. Forward Current vs. Forward Voltage




Figure 4. Relative Intensity vs. Wavelength




Figure 5. Rel. Luminous Intensity vs. Ambient Temperature




Figure 6. Chromaticity Coordinate Shift vs. Forward Current






Figure 7. Forward Voltage vs. Ambient Temperature




Figure 8. Rel. Luminous Intensity vs. Angular Displacement






Figure 9. White Grouping SMD




PACKAGE DIMENSIONS





REEL DIMENSIONS IN MM






TAPE DIMENSIONS IN MM





DRY PACKING

The reel is packed in an anti-humidity bag to protect the devices from absorbing moisture during transportation and storage.





The sealed reel is packed into a cardboard box. A secondary cardboard box is used for shipping purposes.

RECOMMENDED METHOD OF STORAGE

Dry box storage is recommended as soon as the aluminium bag has been opened to prevent moisture absorption. The following conditions should be observed, if dry boxes are not available:

- Storage temperature 10 °C to 30 °C
- Storage humidity ≤ 60 % RH max.

After more than 168 h under these conditions moisture content will be too high for reflow soldering.


In case of moisture absorption, the devices will recover to the former condition by drying under the following condition:

192 hours at 40 °C + 5 °C/ - 0 °C and < 5 % RH (dry air/ nitrogen) or

96 hours at 60 °C + 5 °C and < 5 % RH for all device containers or

24 hours at 100 °C + 5 °C not suitable for reel or tubes. An EIA JEDEC Standard JESD22-A112 Level 3 label is included on all dry bags.

ESD PRECAUTION

Proper storage and handling procedures should be followed to prevent ESD damage to the devices especially when they are removed from the Antistatic Shielding Bag. Electro-Static Sensitive Devices warning labels are on the packaging.
