




Figure 1. Differential Forward Resistance vs. Forward Current




Figure 2. Diode Capacitance vs. Reverse Voltage




Figure 3. Board for R<sub>thJA</sub> definition (in mm)




Figure 4. Recommended foot pads (in mm)






Figure 5. Recommended foot pads (in mm)
