






Figure 2. Typ. Forward Current vs. Forward Voltage




Figure 3. Max. Peak Forward Surge Current vs. Number of Cycles




Figure 4. Typ. Diode Capacitance vs. Reverse Voltage






Figure 5. Typ. Reverse Current vs. Percent of Rated Peak Reverse Voltage

- 3. Council Decision 88/540/EEC and 91/690/EEC Annex A, B and C (transitional substances) respectively.
