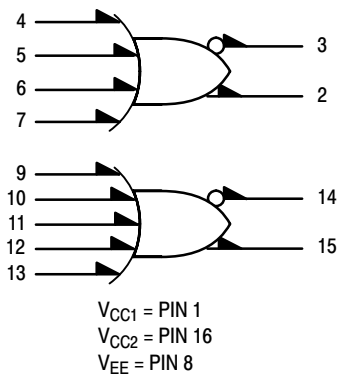

The MC10H209 is a Dual 4–5–input OR/NOR gate. This MECL part is a functional/pinout duplication of the MECL III part MC1688.

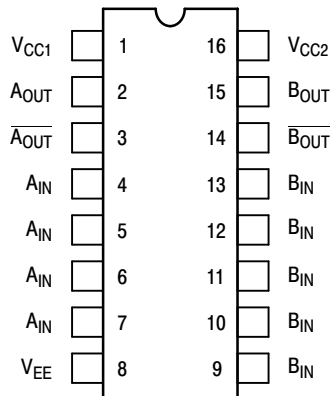
