



Description

The IL66B is an optically coupled isolator employing a gallium arsenide infrared emitter and a silicon photodarlington detector. Switching can be accomplished while maintaining a high degree of isolation between driving and load circuits. They can be used to replace reed and mercury relays with advantages of long life, high speed switching and elimination of magnetic fields.




Figure 1. Forward Voltage vs. Forward Current




Figure 2. Normalized Non-saturated and Saturated CTR $_{\rm CE}$ vs. LED Current




Figure 3. Normalized Non-saturated and Saturated CTR $_{\mbox{\footnotesize{CE}}}$ vs. LED Current




Figure 4. Non-Saturated and Saturated Collector Emitter Current vs. LED Current




Figure 5. High to low Propagation Delay vs. Collector Load Resistance and LED Current






Figure 6. Low to High Propagation Delay vs. Collector Load Resistance and LED Current
