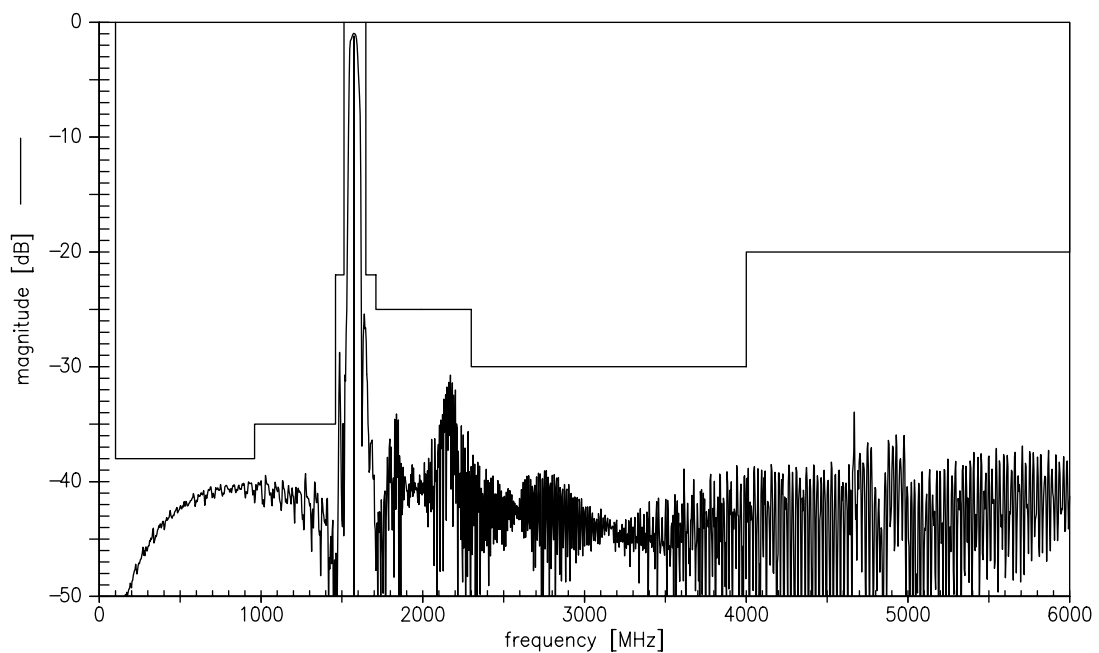

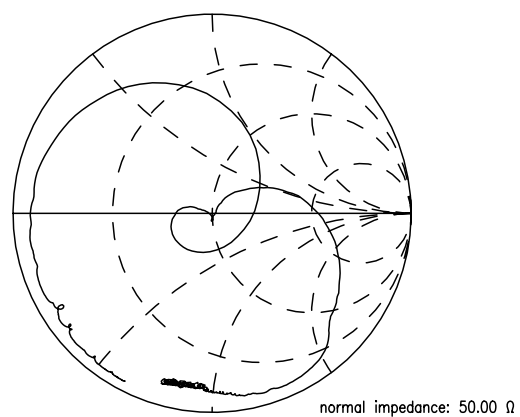
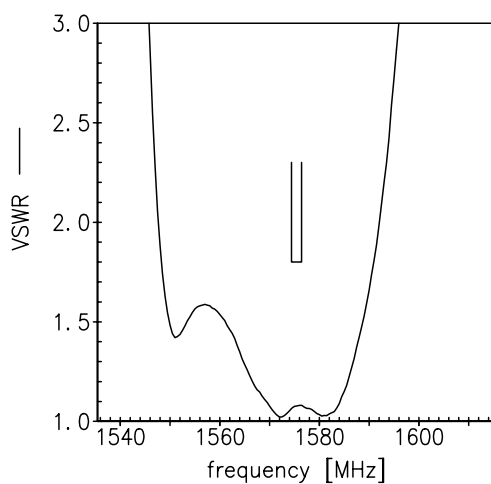


Smith charts
