






Figure 1.. Total Power Dissipation vs. Ambient Temperature




Figure 2.. Transition Frequency vs. Collector Current




Figure 3.. Collector Base Capacitance vs. Collector Base Voltage






Figure 4.. Noise Figure vs. Collector Current





Dimensions of TSDF1220W in mm
