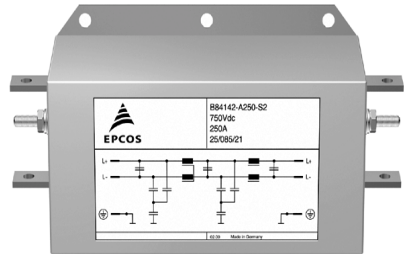
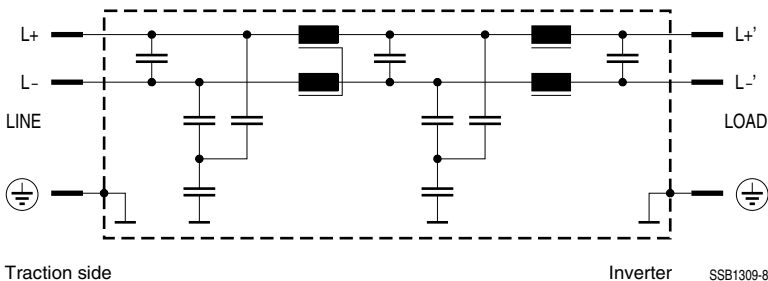

Typical circuit diagram


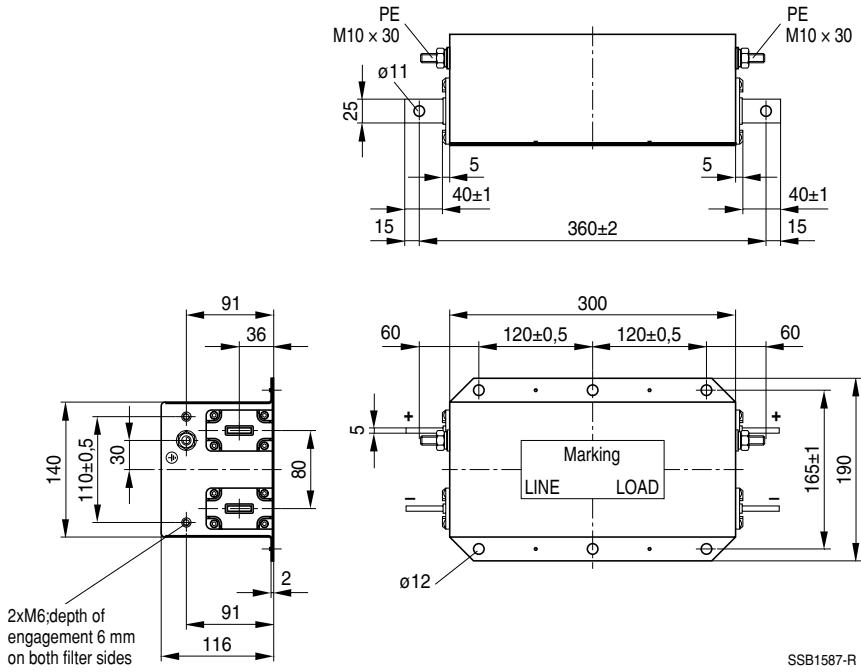

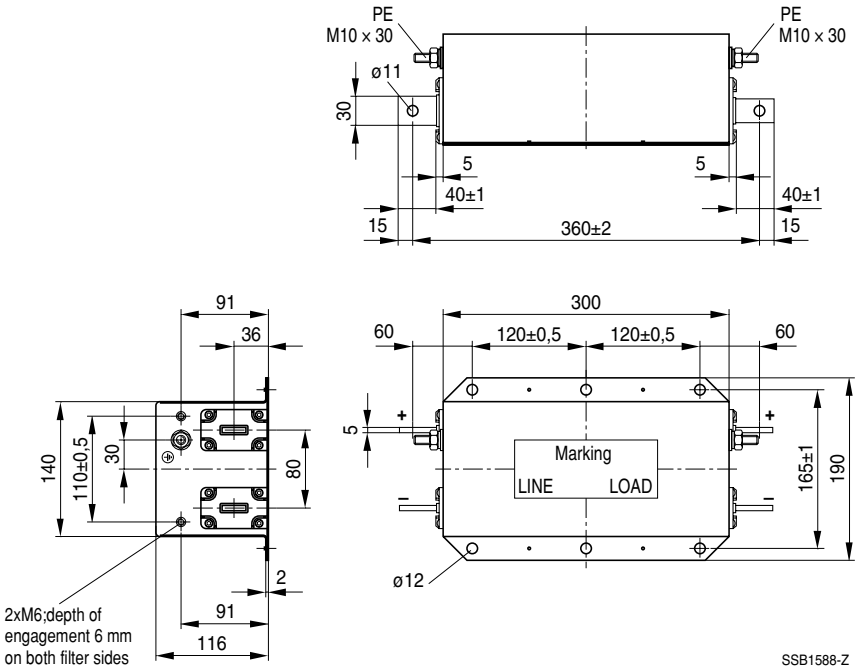

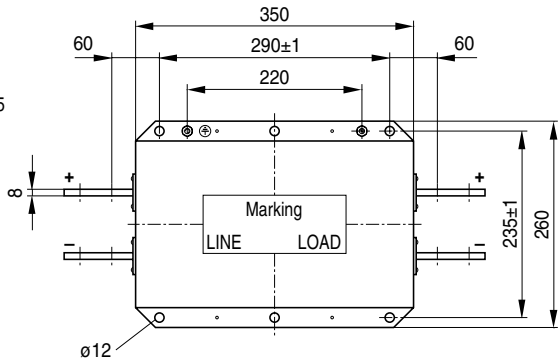
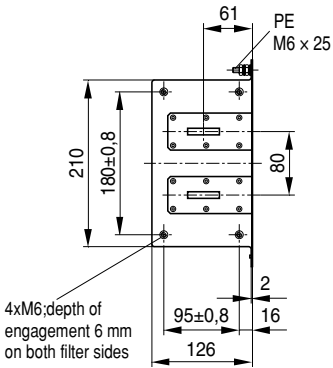
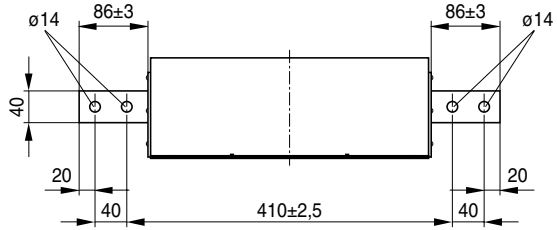
Dimensional drawing B84142-A250-S**

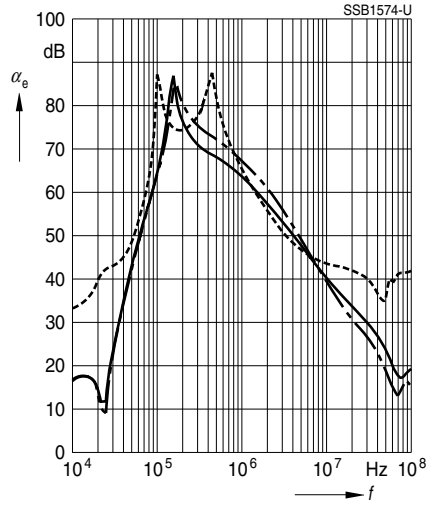
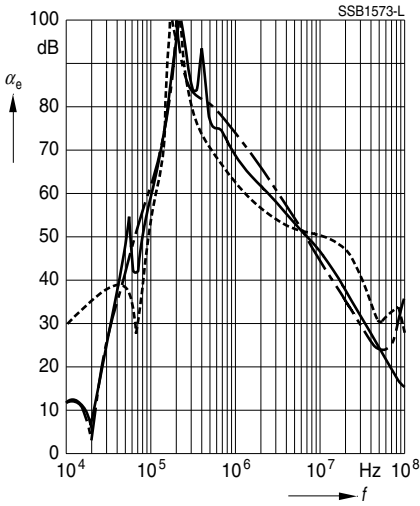
Insertion loss (typical values at $Z = 50 \Omega$)
