
Description

The package of the TLMEK3100 is the PLCC-3 (equivalent to a size B tantalum capacitor).

It consists of a lead frame which is embedded in a white thermoplast. The reflector inside this package is filled up with clear epoxy.

This SMD device consists of a red and yellow chip. So it is possible to choose the color in one device.




Figure 1. Power Dissipation vs. Ambient Temperature




Figure 4. Rel. Luminous Intensity vs. Angular Displacement




Figure 2. Forward Current vs. Ambient Temperature for InGaN




Figure 5. Forward Current vs. Forward Voltage




Figure 3. Pulse Forward Current vs. Pulse Duration




Figure 6. Rel. Luminous Intensity vs. Ambient Temperature






Figure 7. Rel. Lumin. Intensity vs. Forw. Current/Duty Cycle




Figure 10. Relative Intensity vs. Wavelength




Figure 8. Relative Luminous Intensity vs. Forward Current





Figure 9. Relative Intensity vs. Wavelength




Package Dimensions in mm






Mounting Pad Layout
