

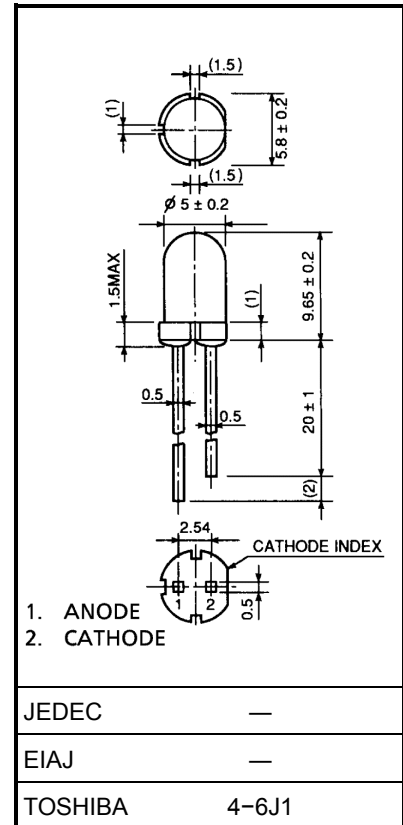

**Precaution**

Please be careful of the following

- Soldering temperature: 260°Cmax Soldering time: 3 s max  
(Soldering portion of lead: Up to 2 mm from the body of the device)
- If the lead is formed, the lead should be formed up to 5 mm from the body of the device without forming stress to the resin. Soldering should be performed after lead forming.
