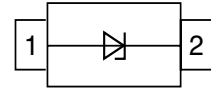
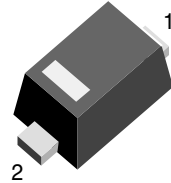

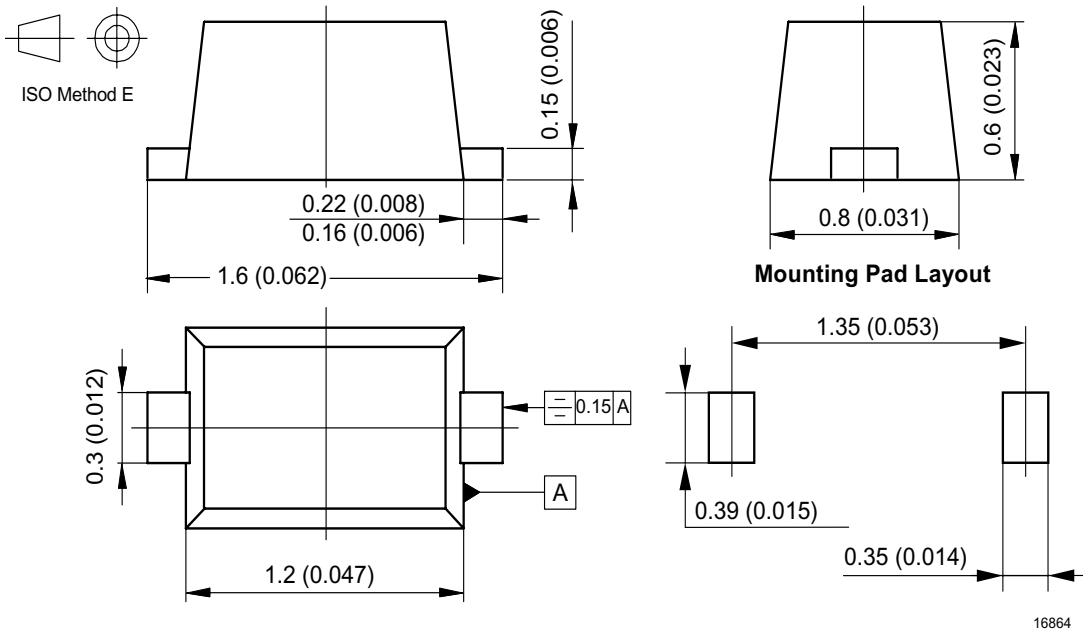

It is the policy of Vishay Semiconductor GmbH to

1. Meet all present and future national and international statutory requirements.
