

Forward Current vs. Collector **Dissipation Temperature Rating** 




Relative Light Current vs. Ambient Temperature Characteristics (Typical)




#### **Sensing Distance Characteristics** (Typical)




**Response Time Measurement** Circuit



**Light Current vs. Forward Current Characteristics (Typical)** 




**Dark Current vs. Ambient Temperature Characteristics** (Typical)



#### **Sensing Position Characteristics** (Typical)




#### Light Current vs. Collector-Emitter **Voltage Characteristics (Typical)**




Collector-Emitter voltage V<sub>CE</sub> (V)
