
# Forward Current vs. Collector Dissipation Temperature Rating




# Forward Current vs. Forward Voltage Characteristics (Typical)




Light Current vs. Forward Current Characteristics (Typical)




Light Current vs. Collector–Emitter Voltage Characteristics (Typical)




Relative Light Current vs. Ambient Temperature Characteristics (Typical)




Dark Current vs. Ambient Temperature Characteristics (Typical)




Response Time vs. Load Resistance Characteristics (Typical)
