


# High Efficiency Blue LED, $\varnothing$ 5 mm Untinted Non - Diffused Package




Figure 1. Power Dissipation vs. Ambient Temperature




Figure 3. Relative Radiant Sensitivity vs. Angular Displacement






Figure 4. Forward Current vs. Forward Voltage








Figure 5. Rel. Luminous Flux vs. Ambient Temperature




Figure 6. Relative Luminous Flux vs. Forward Current






Figure 7. Relative Intensity vs. Wavelength
