

#### **Description**

The SFH620AA/ SFH620AGB features a high current transfer ratio, low coupling capacitance and high isolation voltage. These couplers have a GaAs infrared







emitting diode emitter, which is optically coupled to a silicon planar phototransistor detector, and is incorporated in a plastic DIP-4 package.

The coupling devices are designed for signal transmission between two electrically separated circuits.

The couplers are end-stackable with 2.54 mm lead spacing.

Creepage and clearance distances of > 8.0 mm are achieved with option 6. This version complies with IEC 60950 (DIN VDE 0805) for reinforced insulation up to an operation voltage of 400 V<sub>RMS</sub> or DC.




Figure 1. Switching Times (Typical Values) Linear Operation (saturated)




Figure 2. Current Transfer Ratio (CTR) vs. Temperature




Figure 4. Diode Forward Voltage (typ.) vs. Forward Current




Figure 3. Output Characteristics (typ.) Collector Current vs. Collector-Emitter Voltage




Figure 5. Transistor Capacitance (typ.) vs. Collector-Emitter Voltage




Figure 6. Permissible Pulse Handling Capability Forward Current vs. Pulse Width




Figure 7. Permissible Power Dissipation vs. Ambient Temperature





Figure 8. Permissible Diode Forward Current vs. Ambient Temperature


