




#### ■ Terminal Arrangement/Internal Connections (Top View)




Connection Diagram






## LED forward current vs. Ambient temperature



#### Continuous load current vs. Ambient temperature




## LED forward current vs. LED forward voltage






## Continuous load current vs. On-state voltage




#### On-state resistance vs. Ambient temperature




Trigger LED forward current vs.
Ambient temperature




## Turn ON, Turn OFF time vs. LED forward current




## Turn ON, Turn OFF time vs. Ambient temperature
