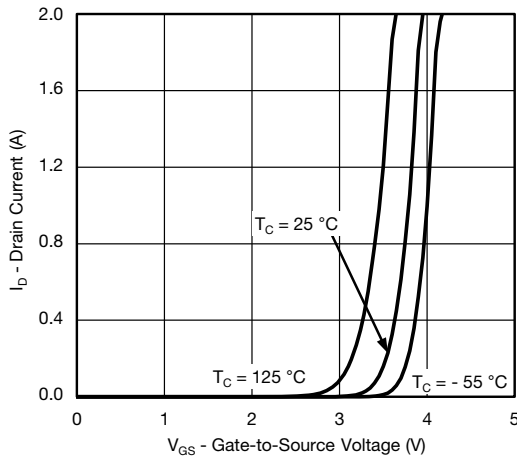

On-Resistance vs. Drain Current

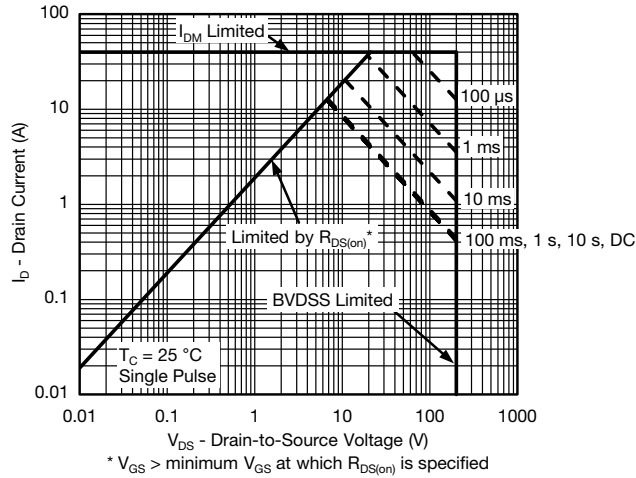

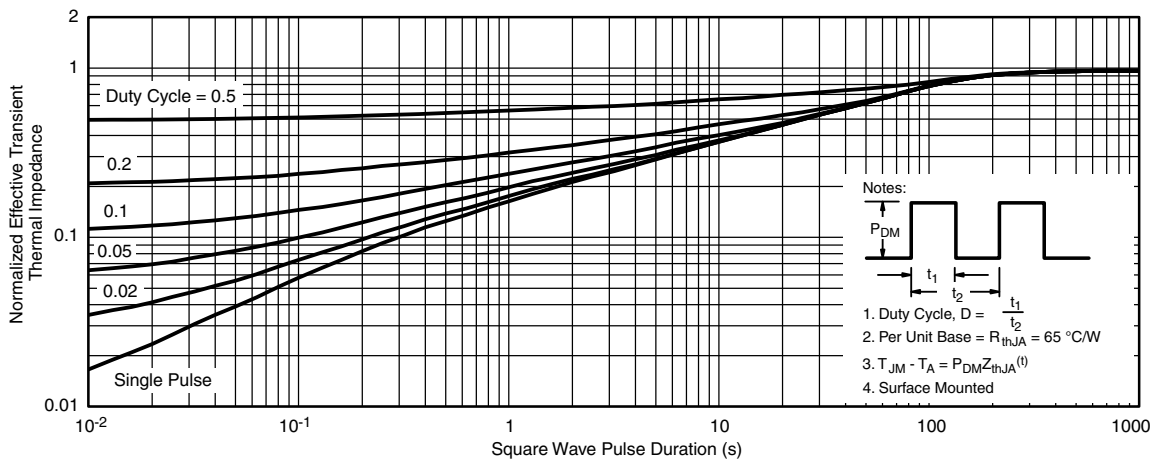

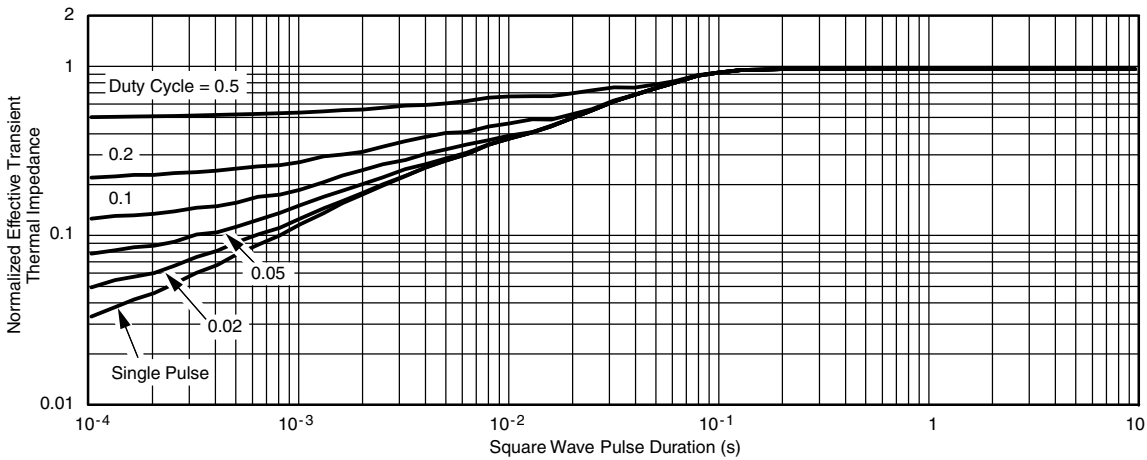

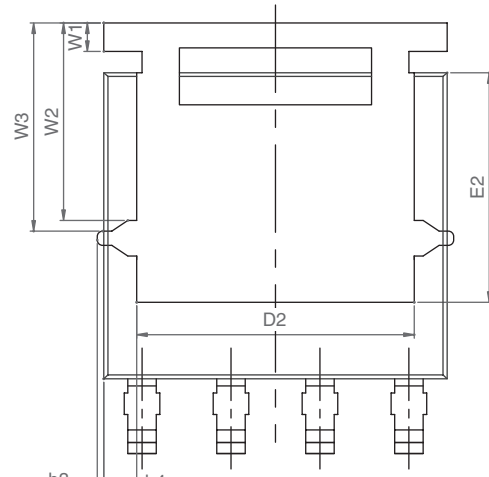
PowerPAK® SO-8L CASE OUTLINE



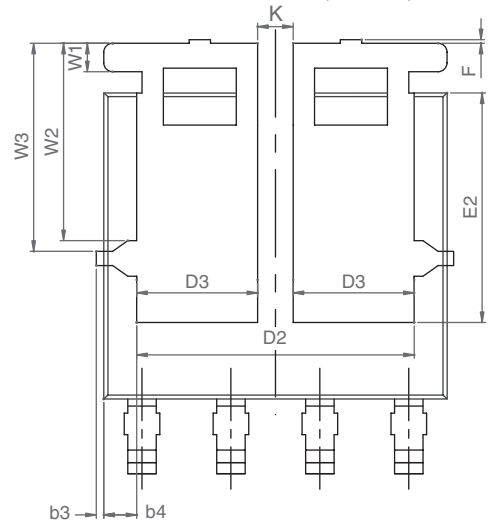
TOPSIDE VIEW



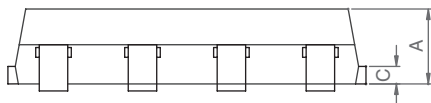
0.25 Gauge Line
