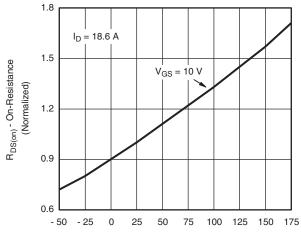

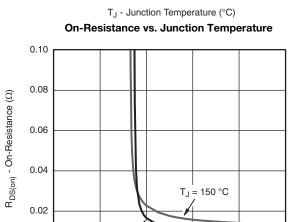

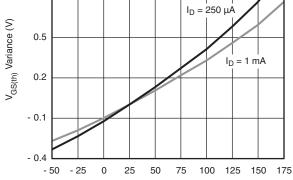


V<sub>GS</sub> - Gate-to-Source Voltage (V)

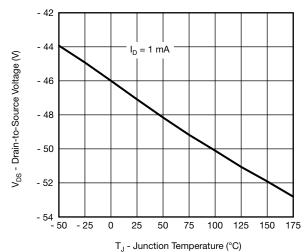

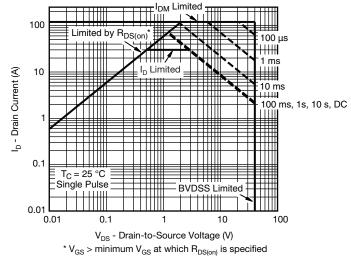
Drain Source Breakdown vs. Junction Temperature

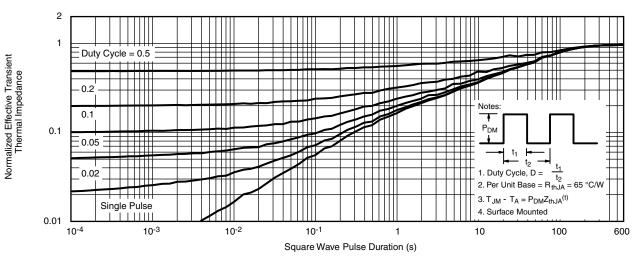

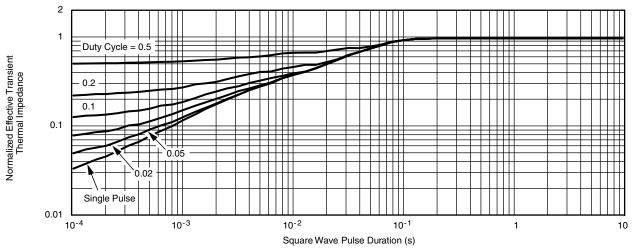
#### Safe Operating Area

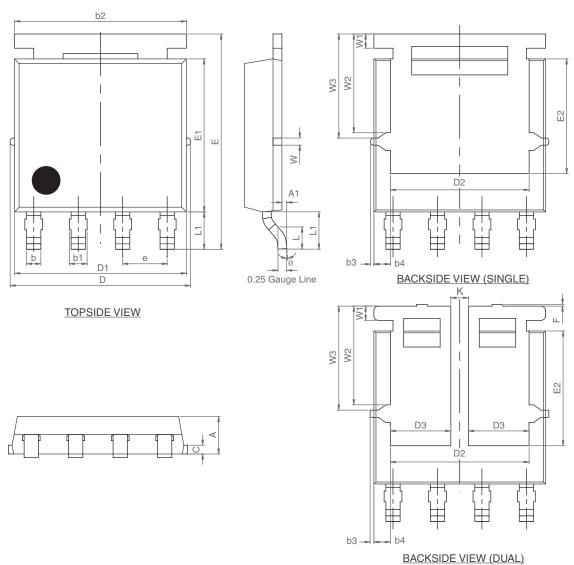
