## 1. Product profile

### 1.1 General description

Planar passivated high commutation three quadrant triac in a SOT404 plastic package intended for use in circuits where high static and dynamic dV/dt and high dl/dt can occur. This "series C" triac will commutate the full rated RMS current at the maximum rated junction temperature without the aid of a snubber.




Fig 1. RMS on-state current as a function of surge duration; maximum values




Fig 2. RMS on-state current as a function of mounting base temperature; maximum values




Fig 3. Total power dissipation as a function of RMS on-state current; maximum values






Fig 4. Non-repetitive peak on-state current as a function of the number of sinusoidal current cycles; maximum values




rig 6. Transient thermal impedance from junction to mounting base as a function of pulse duration

Fig 7. Normalized gate trigger current as a function of junction temperature




Fig 8. Normalized latching current as a function of junction temperature





Fig 9. Normalized holding current as a function of junction temperature






Fig 12. Package outline SOT404 (D2PAK)
