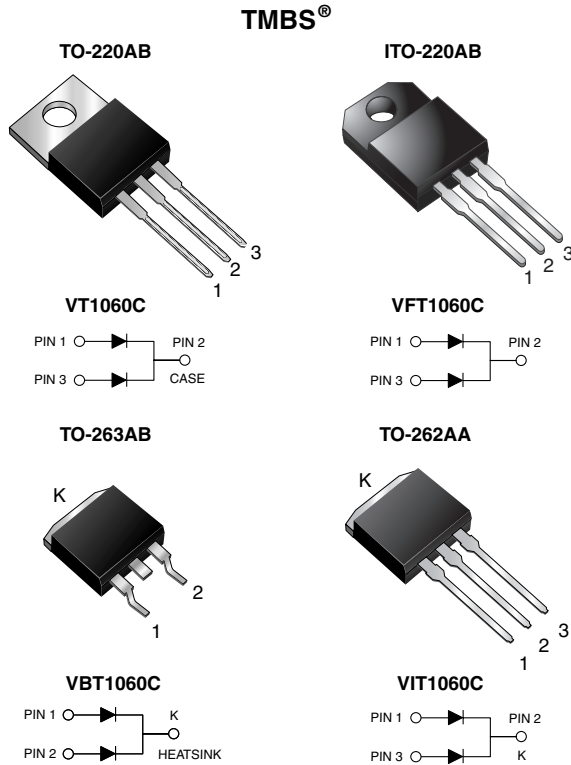

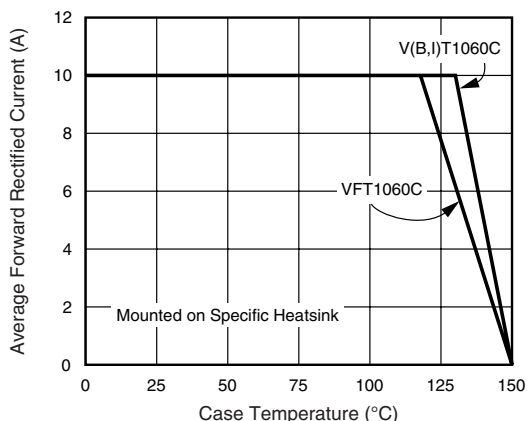


Figure 1. Maximum Forward Current Derating Curve

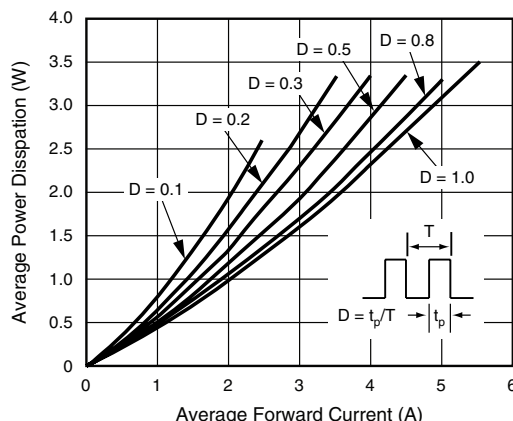


Figure 2. Forward Power Dissipation Characteristics Per Diode

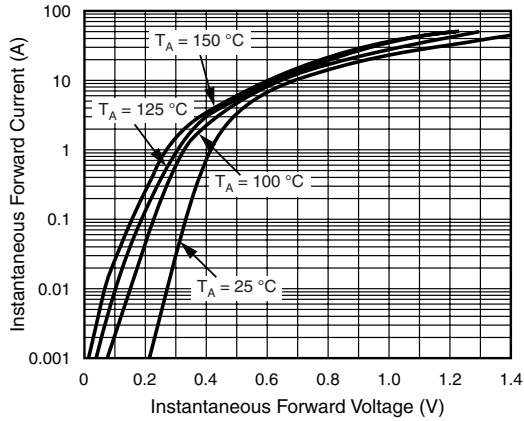


Figure 3. Typical Instantaneous Forward Characteristics Per Diode

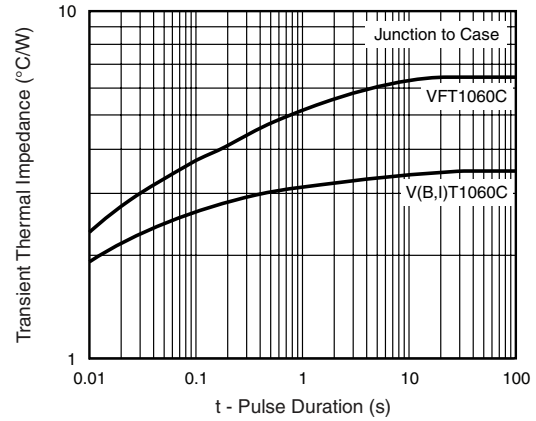


Figure 5. Typical Transient Thermal Impedance Per Diode

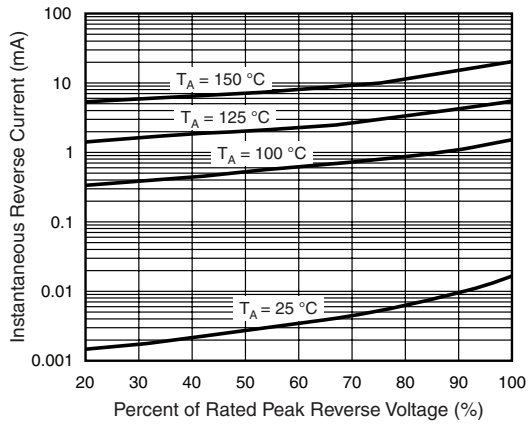


Figure 4. Typical Reverse Characteristics Per Diode

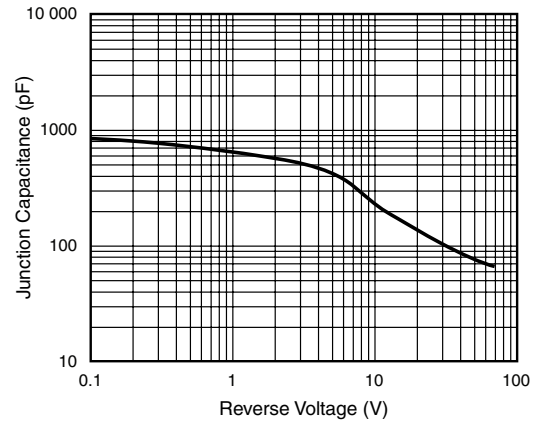


Figure 6. Typical Junction Capacitance Per Diode

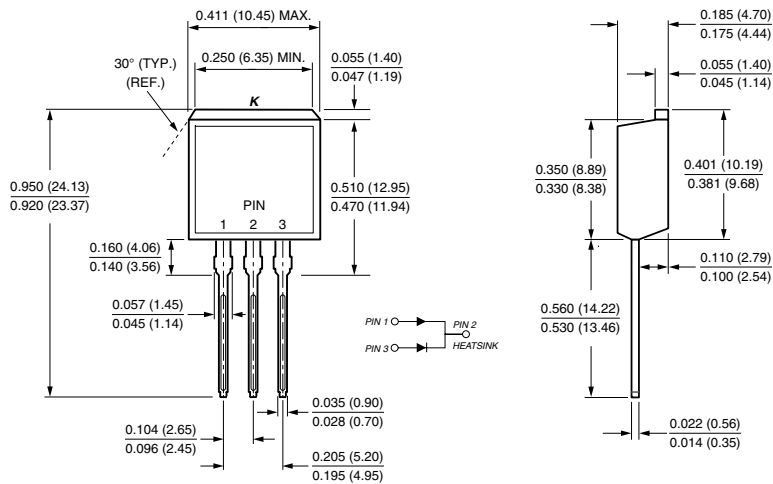

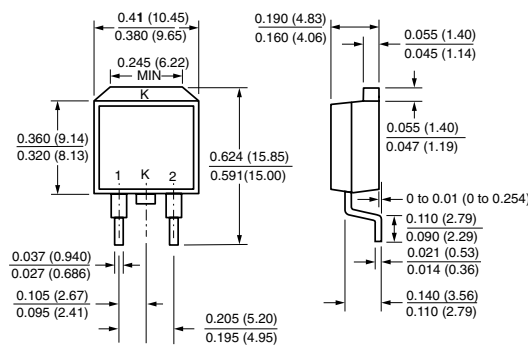

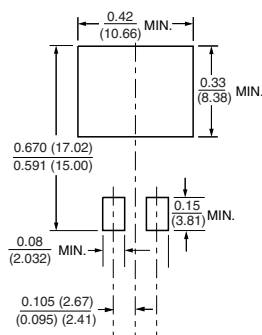
