

# **Optocoupler with Phototransistor Output**

### **Description**


The K814P/K824P/K844P consist of a phototransistor optically coupled to 2 gallium arsenide infrared-emitting diodes (reversed polarity) in an 4-lead up to 16-lead plastic dual inline package. The elements are mounted on one leadframe using a **coplanar technique**, providing a fixed distance between input and output for highest safety requirements.








Figure 1. Test circuit, non-saturated operation




Figure 2. Test circuit, saturated operation




Figure 3. Switching times




Figure 4. Total Power Dissipation vs. Ambient Temperature




Figure 5. Forward Current vs. Forward Voltage




Figure 6. Relative Current Transfer Ratio vs.

Ambient Temperature




Figure 7. Collector Dark Current vs. Ambient Temperature




Figure 8. Collector Current vs. Forward Current




Figure 9. Collector Current vs. Collector Emitter Voltage




Figure 10. Collector Emitter Saturation Voltage vs. Collector Current





Figure 11. Current Transfer Ratio vs. Forward Current






Figure 12. Turn on / off Time vs. Forward Current






Figure 13. Turn on / off Time vs. Collector Current






#### Dimensions of K814P in mm





after mounting on PC board











after mounting on PC board










