


Fig 1. RMS on-state current as a function of surge

duration; maximum values






Fig 2. RMS on-state current as a function of mounting base temperature; maximum values




 α = conduction angle





Fig 6. Transient thermal impedance from junction to mounting base as a function of pulse duration



Normalized latching current as a function of Fig 8. junction temperature





Fig 9. Normalized holding current as a function of junction temperature








Fig 12. Package outline SOT404 (D2PAK)
