Description

CPC1004N is a miniature, low-voltage, low on-resistance, normally open (1-Form-A) DC solid state relay in a 4-pin SOP package. The relay uses optically coupled MOSFET technology to provide 1500V_{rms} of input to output isolation. The efficient MOSFET switch and photovoltaic die use Clare's patented OptoMOS architecture while the optically coupled output is controlled by a highly efficient GaAIAs infrared LED.

The CPC1004N uses Clare's state of the art double-molded vertical construction packaging to produce one of the world's smallest relays. The CPC1004N is ideal for replacing larger, less-reliable reed and electromechanical relays.




















Typical Blocking Voltage Distribution $(T_A=25^{\circ}C)$









LED Forward Current (mA)

Typical Turn-Off vs. LED Forward Current $(I_L=100mA)$





Moisture Sensitivity

Board Wash


Clare recommends the use of no-clean flux formulations. However, board washing to remove flux residue is acceptable. Since Clare employs the use of silicone coating as an optical waveguide in many of its optically isolated products, the use of a short drying bake could be necessary if a wash is used after solder reflow processes. Chlorine- or Fluorine-based solvents or fluxes should not be used. Cleaning methods that employ ultrasonic energy should not be used.




