






Figure 1. Pulse Derating Curve




Figure 3. Non -Repetitive Peak Pulse Power vs. Pulse Time




Figure 2. Pulse Waveform




Figure 4. Typical Capacitance vs. Reverse Voltage




Figure 5. Typical Reverse Voltage vs. Reverse Current







Figure 6. Typical Clamping Voltage vs. Peak Pulse Current
