






F Typical Inductance vs. Current Characteristics:





After the potting material is cured, the core, wire and termination of the product have to be checked if any reduced electrical or mechanical functions or destructions have occurred.

The responsibility for the applicability of customer specific products and use in a particular customer design is always within the authority of the customer. All technical specifications for standard products do also apply for customer specific products.

Washing varnish agent that is used during the production to clean the application might damage or change the characteristics of the wire insulation, the marking or the plating. The washing varnish agent could have a negative effect on the long turn function of the product.

Direct mechanical impact to the product shall be prevented as the ferrite material of the core could flake or in the worst case it could break.

Product specific:

Follow all instructions mentioned in the datasheet, especially:

- •The solder profile has to be complied with according to the technical wave soldering specification, otherwise no warranty will be sustained
- •All products are supposed to be used before the end of the period of 12 months based on the product date-code, if not a 100% solderability can't be warranted.
- . Violation of the technical product specifications such as exceeding the nominal rated current will result in the loss of warranty.
- •Strong force and high accelerations of the component size 1111 might have the effect of damage the electrical connection or to harm the circuit board due to the heavy weight of the component. These damages will result in the loss of warranty.
