The package of the TLMA3100 is the PLCC-2 (equivalent to a size B tantalum capacitor).


It consists of a lead frame which is embedded in a white thermoplast. The reflector inside this package is filled up with clear epoxy.




Figure 1. Power Dissipation vs. Ambient Temperature




Figure 2. Forward Current vs. Ambient Temperature





Figure 3. Rel. Luminous Intensity vs. Angular Displacement




Figure 4. Forward Current vs. Forward Voltage





Figure 6. Relative Luminous Intensity vs. Forward Current



Rel. Luminous Intensity vs. Ambient Temperature





Figure 7. Relative Intensity vs. Wavelength




## **PACKAGE DIMENSIONS** in millimeters
