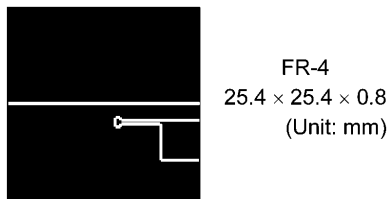

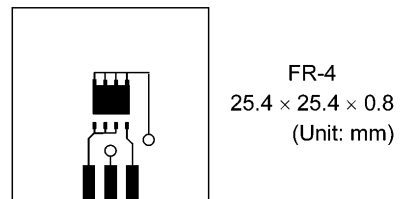

**Fig. 6.2.1 Switching Time Test Circuit**

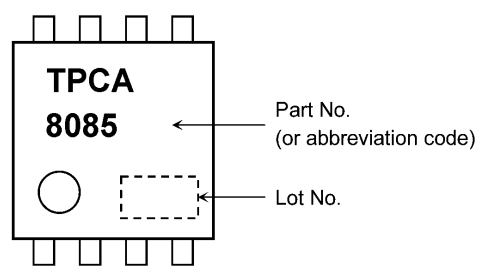

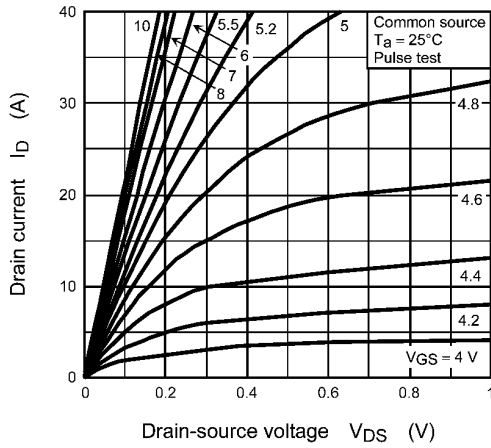

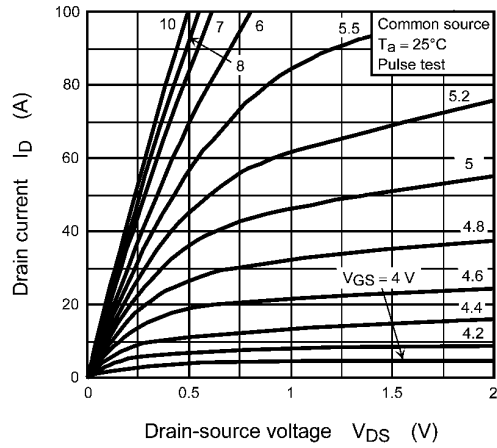

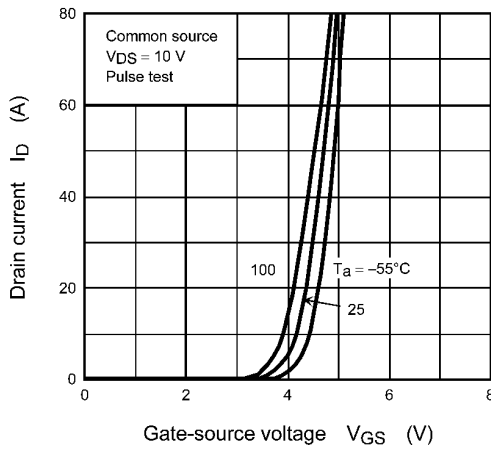

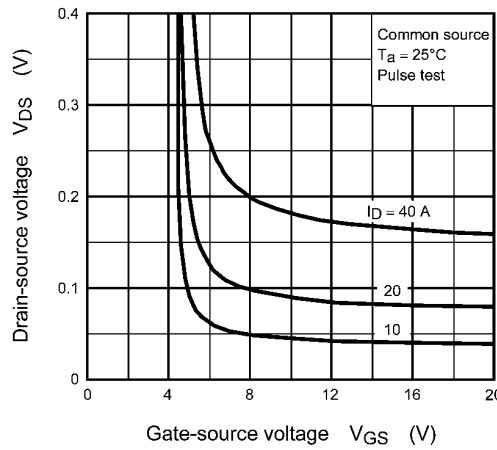
**Fig. 8.1  $I_D - V_{DS}$**



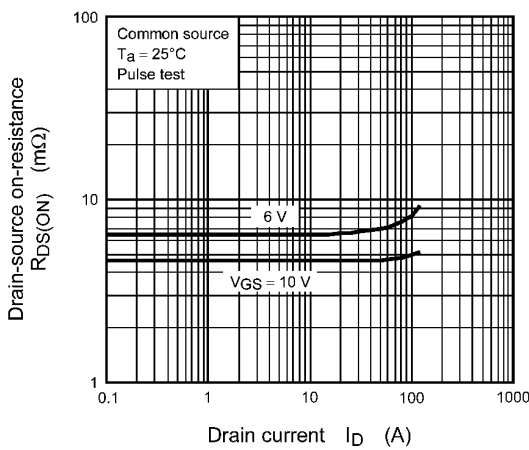
**Fig. 8.2  $I_D - V_{DS}$**



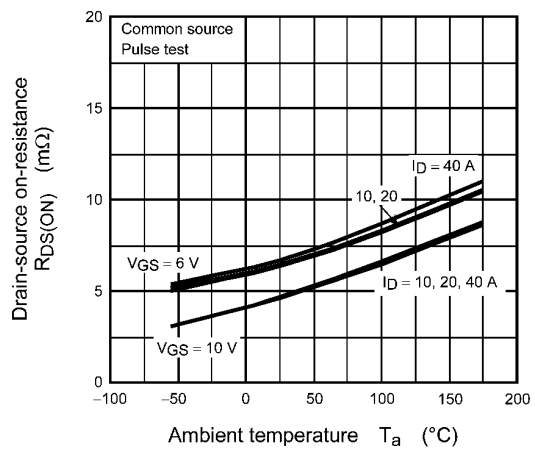
**Fig. 8.3  $I_D - V_{GS}$**

**Fig. 8.6  $R_{DS(ON)} - T_a$  (Note 7)**

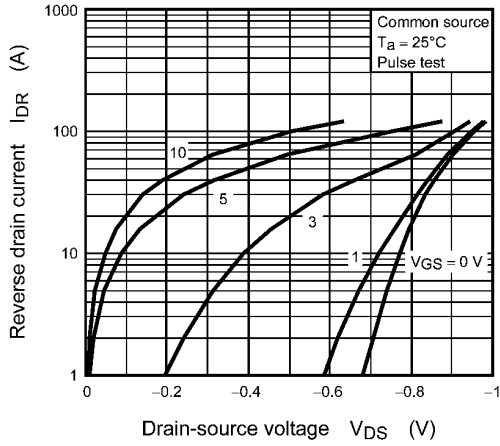


Fig. 8.7  $I_{DR} - V_{DS}$

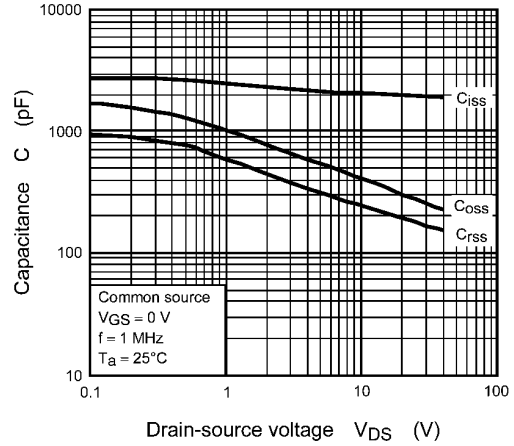


Fig. 8.8 Capacitance -  $V_{DS}$

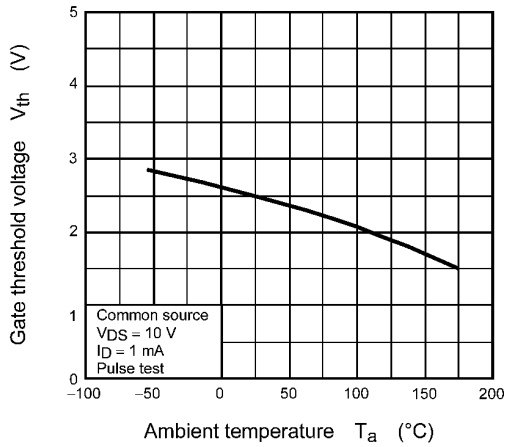


Fig. 8.9  $V_{th} - T_a$  (Note 7)

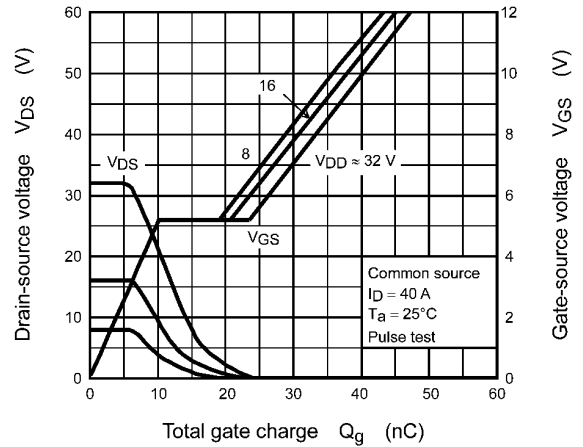


Fig. 8.10 Dynamic Input/Output Characteristics

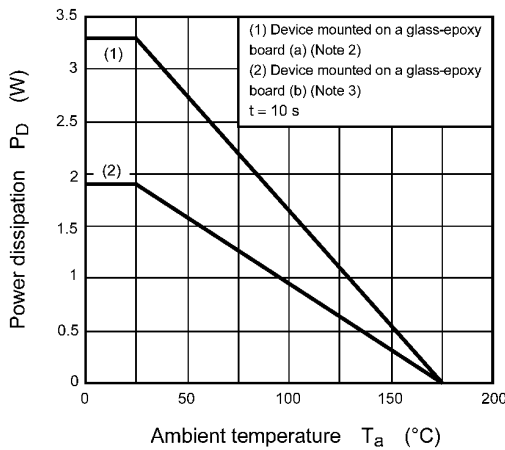


Fig. 8.11  $P_D - T_a$  (Note 7)  
 (Guaranteed Maximum)

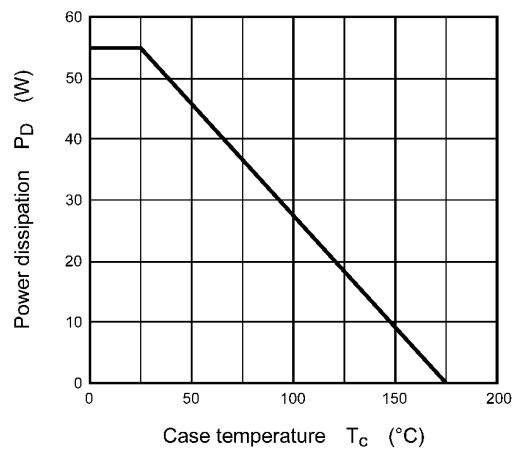
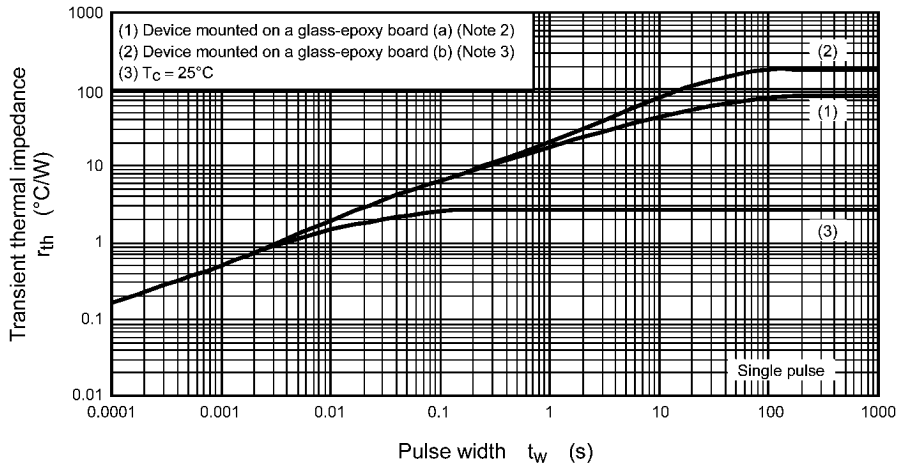
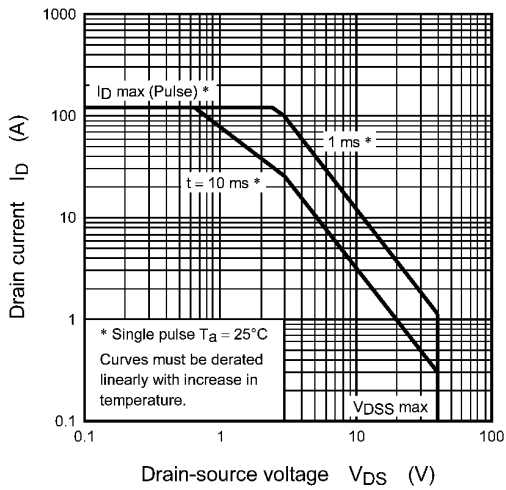


Fig. 8.12  $P_D - T_c$  (Note 7)
