





Figure 1. DERATING FACTOR OF FORWARD BIAS SAFE OPERATING AREA




Figure 3. FORWARD BIAS SAFE OPERATING AREA




Figure 2. TOTAL POWER DISSIPATION vs.




Figure4. SINGLE AVALANCHE ENERGY DERATING FACTOR





Figure 5. TRANSIENT THERMAL RESISTANCE vs. PULSE WIDTH

Figure 6. FORWARD TRANSFER CHARACTERISTICS




Figure 7. DRAIN CURRENT vs. DRAIN TO SOURCE VOLTAGE 140 Pulsed 120 lo - Drain Current - A 100 V_Gs = 10 V 80 60 40 20 0

Figure8. FORWARD TRANSFER ADMITTANCE vs. DRAIN CURRENT




Figure9. DRAIN TO SOURCE ON-STATE RESISTANCE vs. GATE TO SOURCE VOLTAGE 40 Pulsed




Figure 10. DRAIN TO SOURCE ON-STATE RESISTANCE vs. DRAIN CURRENT









Figure 11. GATE TO SOURCE THRESHOLD VOLTAGE vs. CHANNEL TEMPERATURE



















