

Figure 2. Safe operating area




Figure 3. Thermal impedance




Figure 4. Output characteristics




Figure 5. Transfer characteristics




Figure 6. Gate charge vs gate-source voltage




Figure 7. Static drain-source on-resistance









Figure 8. Capacitance variations**Figure 9. Normalized gate threshold voltage vs temperature****Figure 10. Normalized on-resistance vs temperature****Figure 11. Normalized $V_{(BR)DSS}$ vs temperature****Figure 12. Source-drain diode forward characteristics**

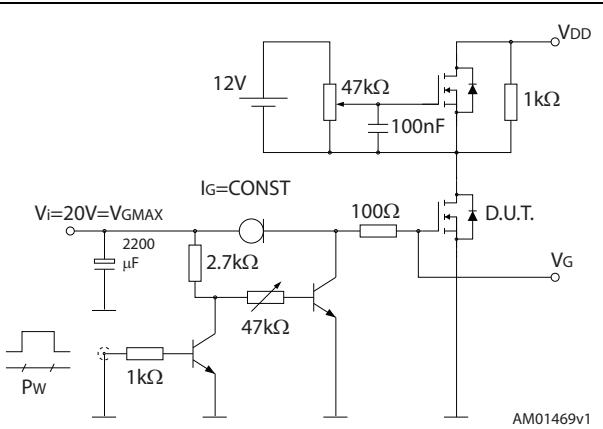


Figure 15. Test circuit for inductive load switching and diode recovery times



Figure 16. Unclamped inductive load test circuit

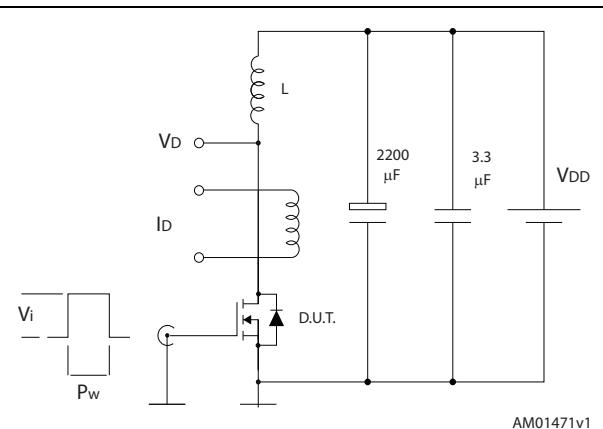
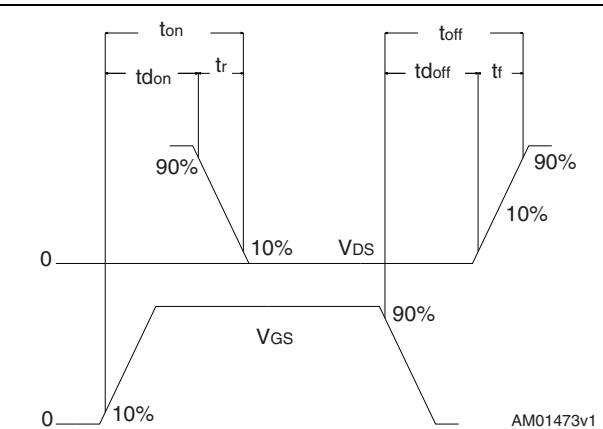


Figure 17. Unclamped inductive waveform

Figure 19. PowerFLAT™ 5x6 type S-R drawing




Figure 21. PowerFLAT™ 5x6 tape^(a)

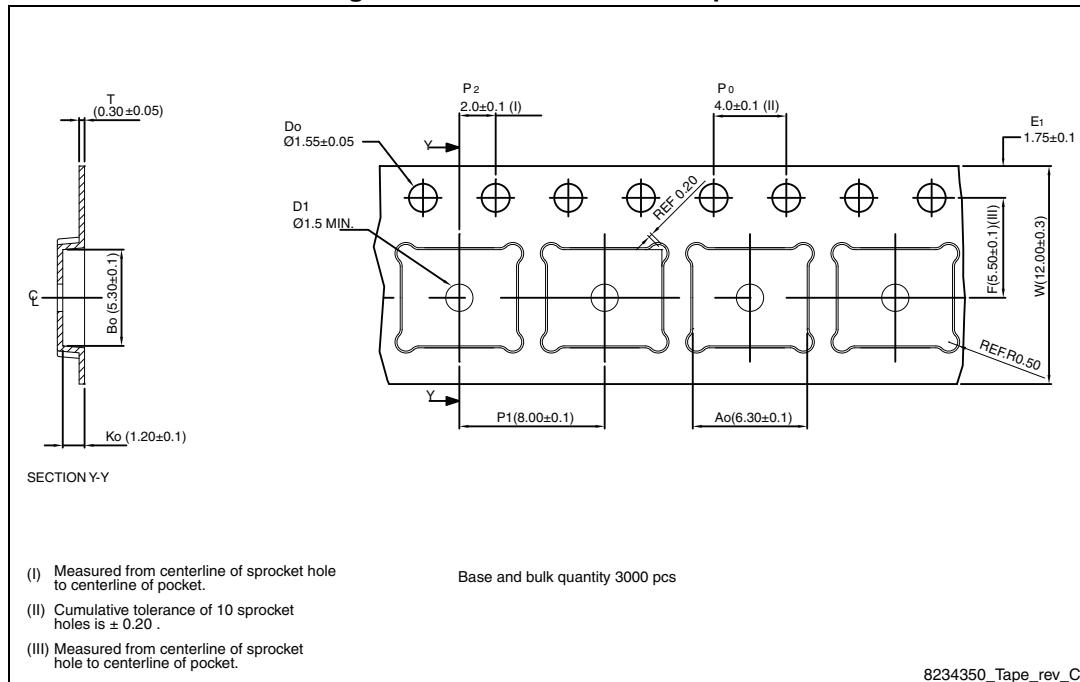
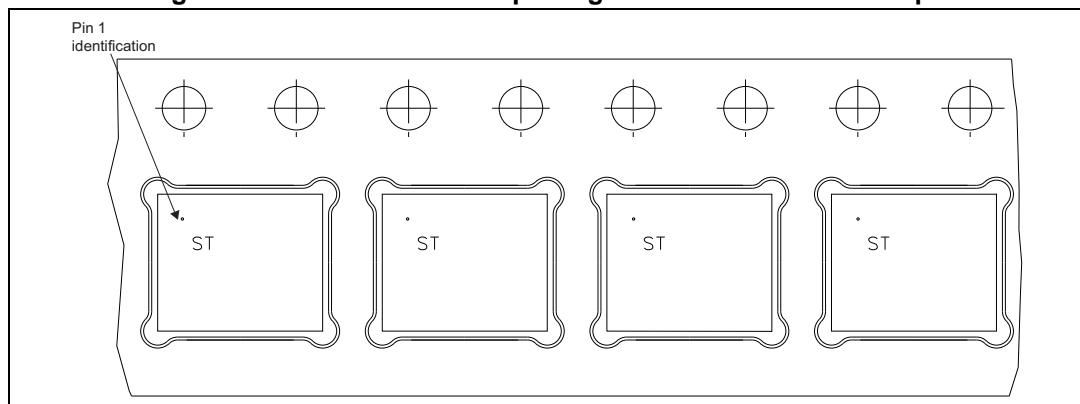
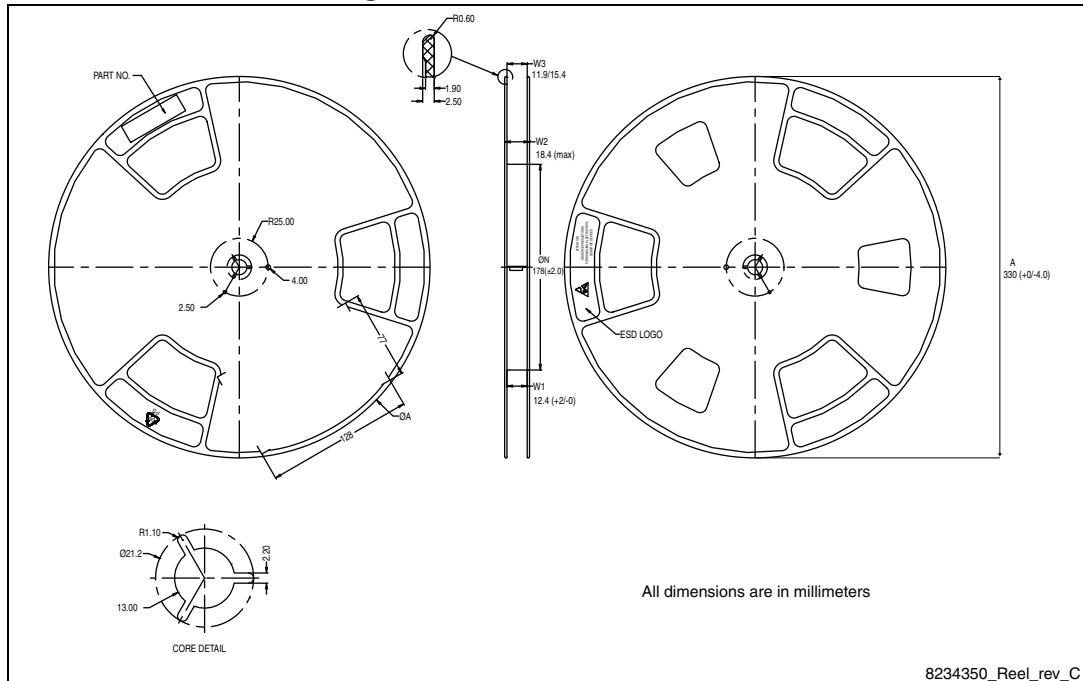


Figure 22. PowerFLAT™ 5x6 package orientation in carrier tape
