




The Super Bright Orange device is made with AlGaInP (on GaAs substrate) light emitting diode chip.







RELATIVE INTENSITY Vs. WAVELENGTH










CIRCUIT DESIGN NOTES

- 2.LEDs mounted in parallel should each be placed in series with its own current-limiting resistor.





- NOTES:



 3.Number of reflow process shall be 2 times or less.




