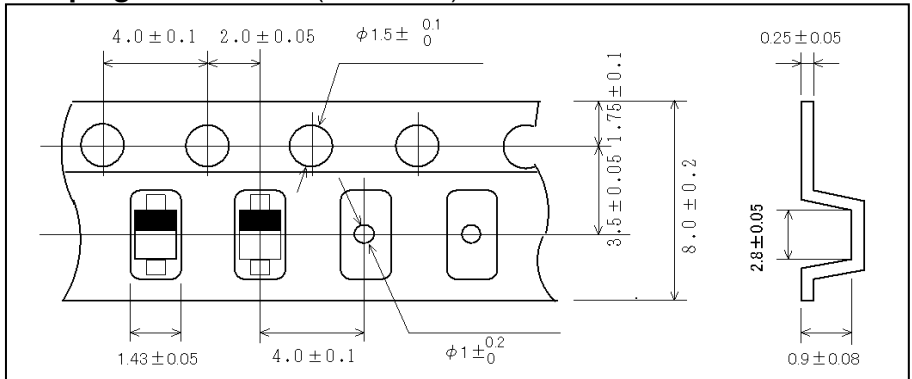
### ●Land Size Figure (Unit : mm)

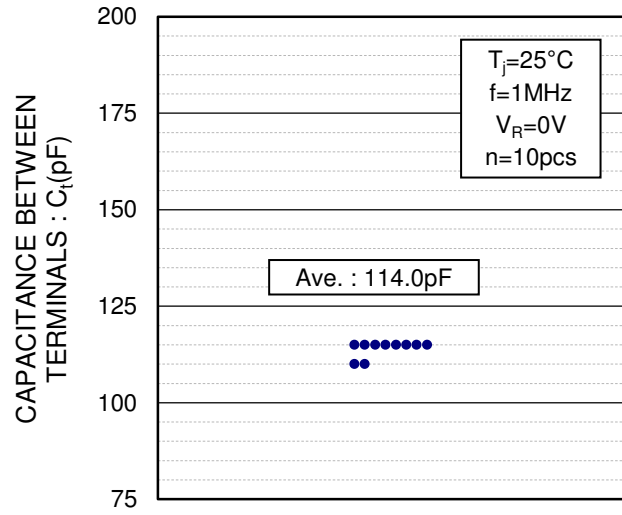
●Electrical Characteristic Curves



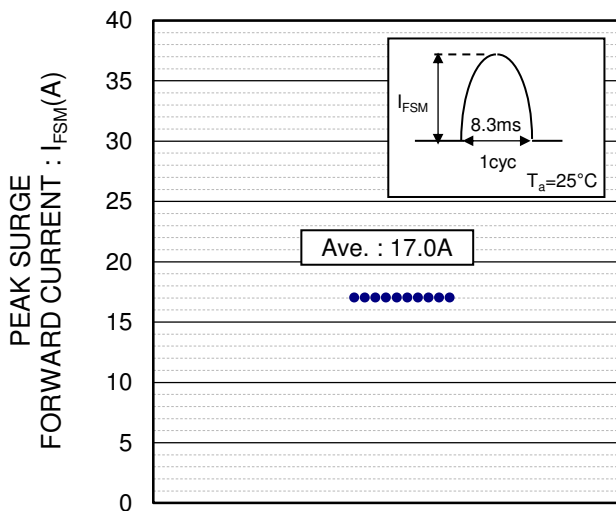

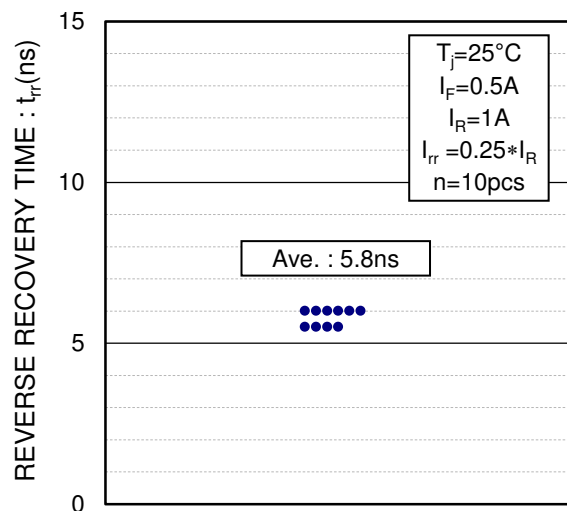
$I_R$  DISPERSION MAP



$C_t$  DISPERSION MAP

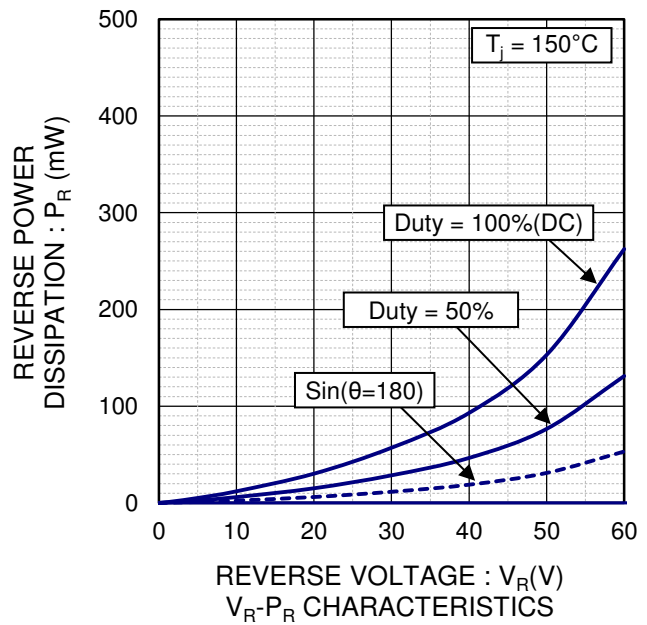
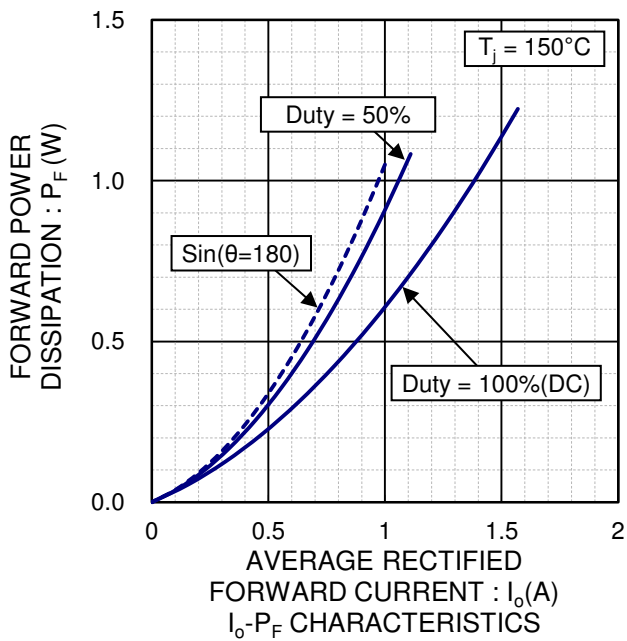
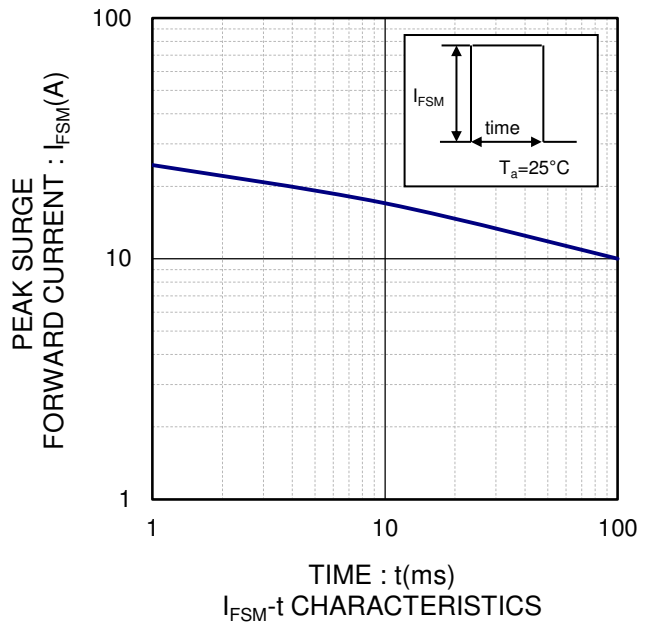
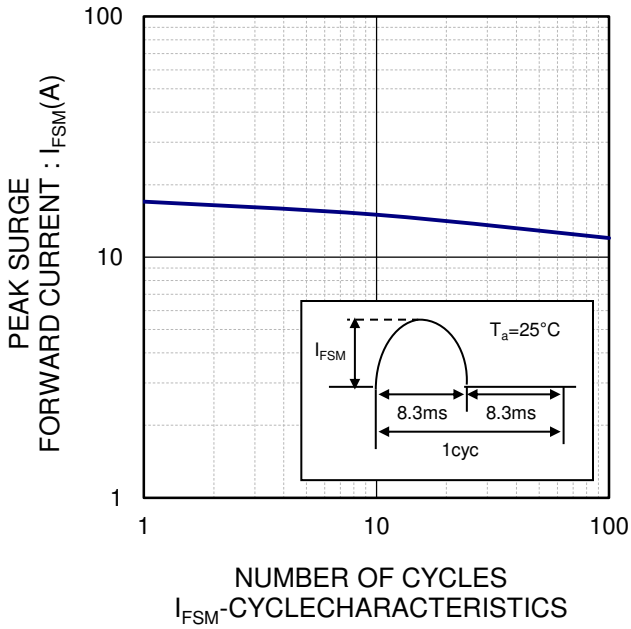


$I_{FSM}$  DISPERSION MAP

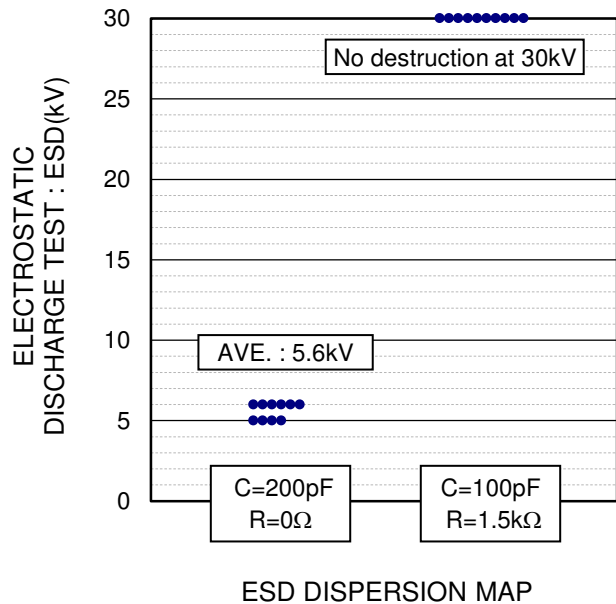
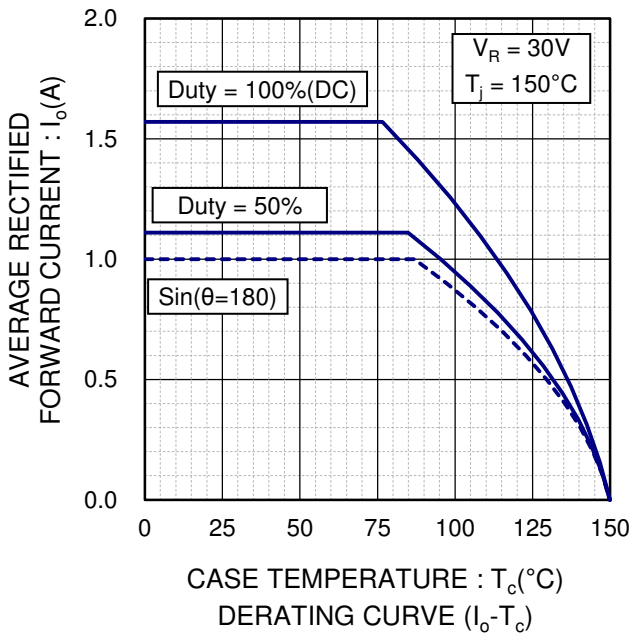
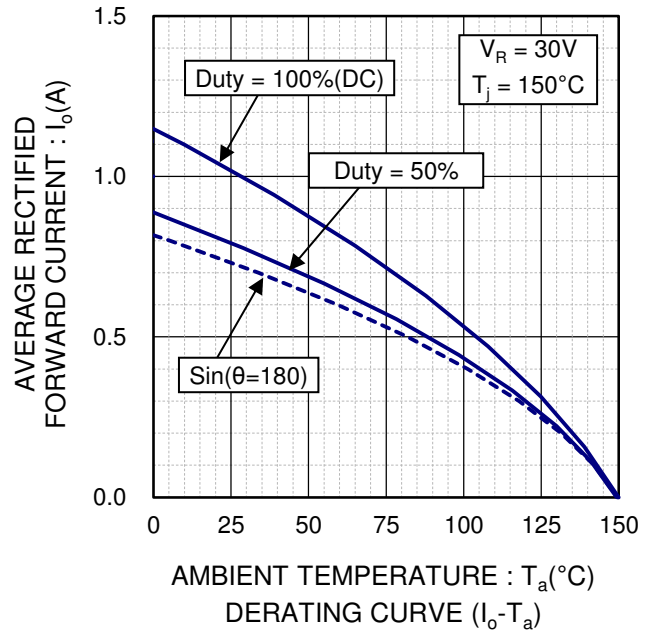
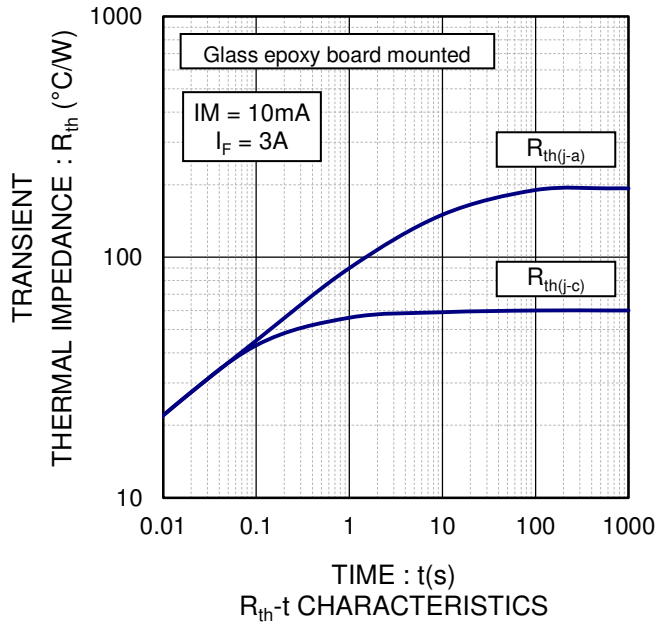
