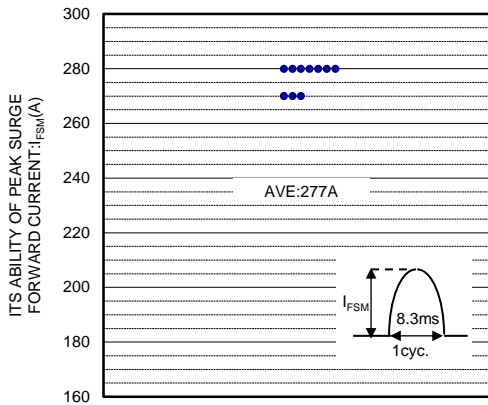
$V_F$  DISPERSION MAP



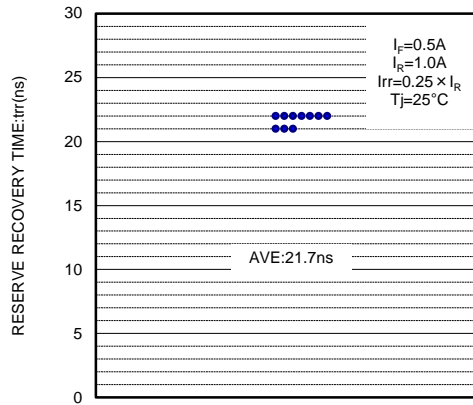
$I_R$  DISPERSION MAP



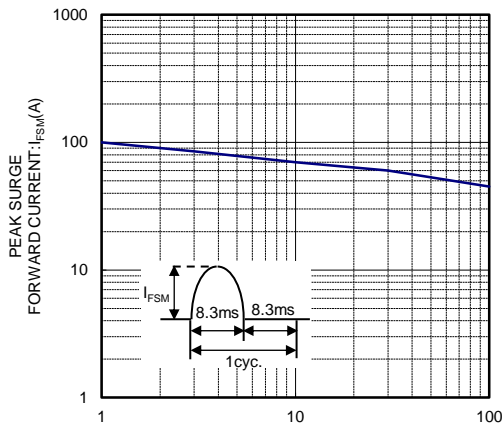
$C_t$  DISPERSION MAP



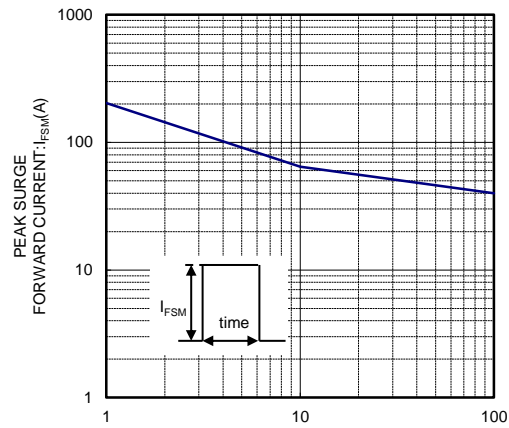
$I_{FSM}$  DISPERSION MAP



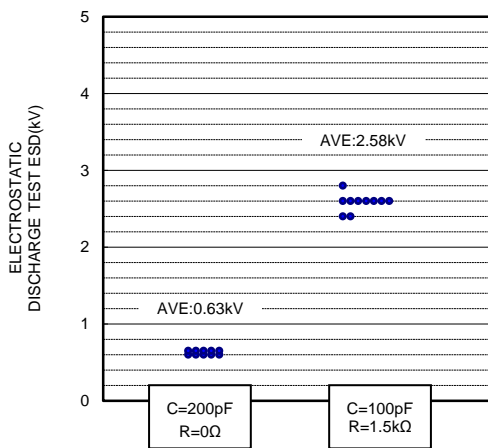
$t_{rr}$  DISPERSION MAP



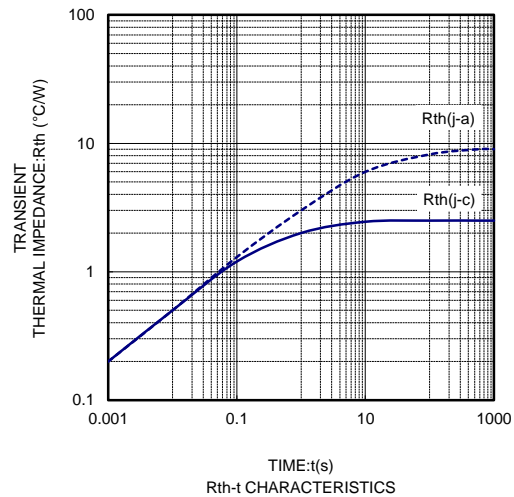
$I_{FSM}$  CYCLE CHARACTERISTICS



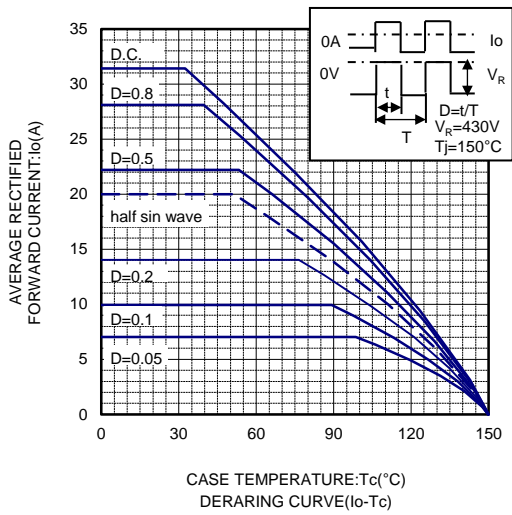
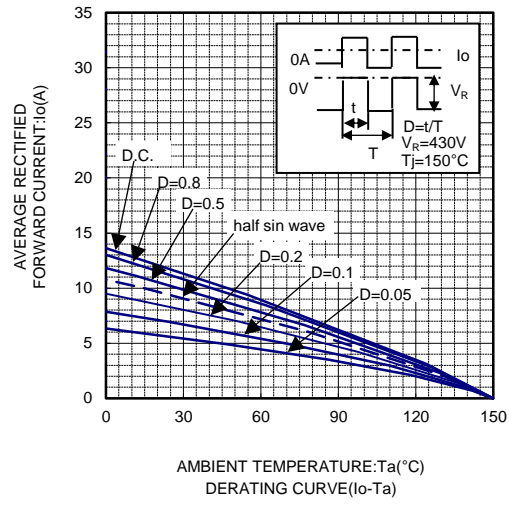
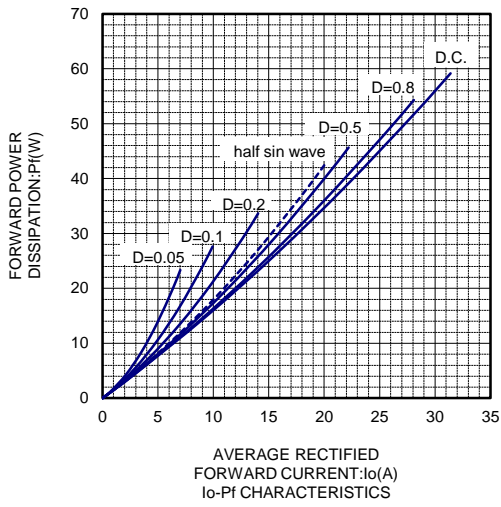
$I_{FSM}$ - $t$  CHARACTERISTICS
