


TEST CIRCUIT 1 AVALANCHE CAPABILITY

TEST CIRCUIT 2 SWITCHING TIME





















FORWARD TRANSFER ADMITTANCE vs. DRAIN CURRENT

CAPACITANCE vs. DRAIN TO SOURCE VOLTAGE




