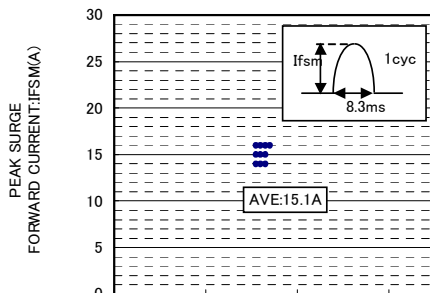
VF DISPERSION MAP



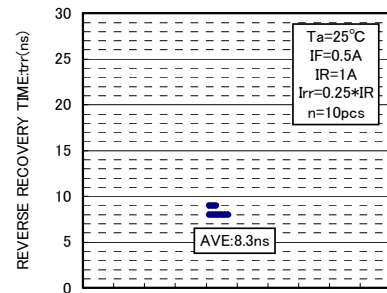
IR DISPERSION MAP



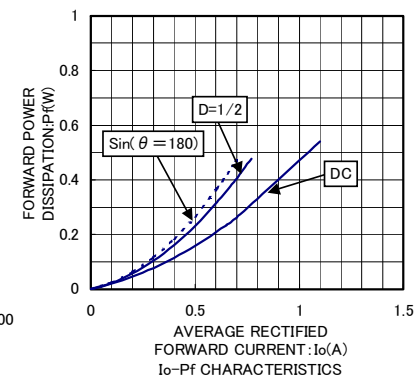
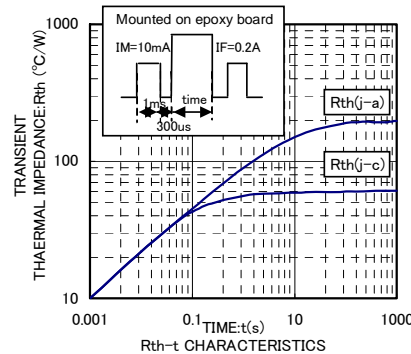
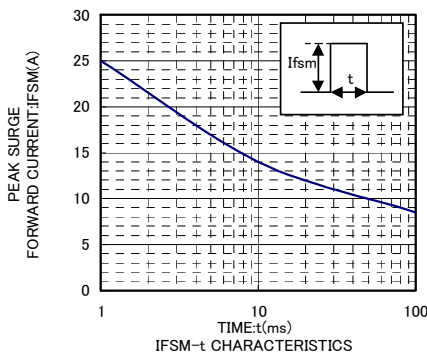
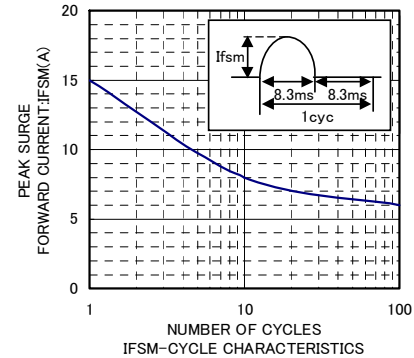
Ct DISPERSION MAP

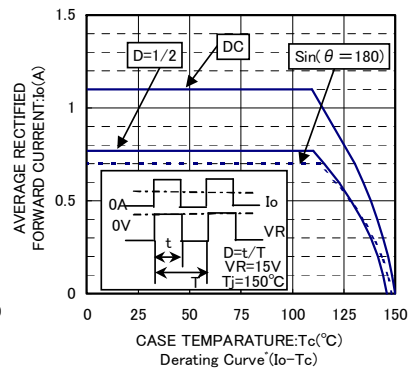
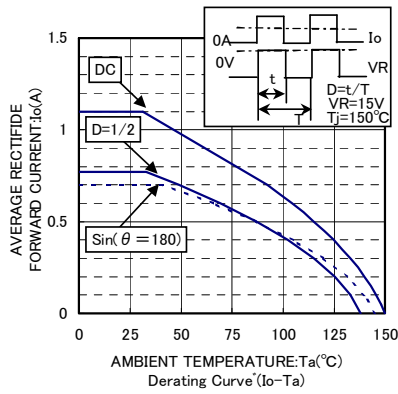
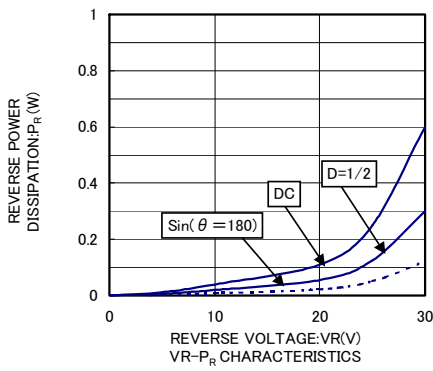


IFSM DISPERSION MAP
