#### DESCRIPTION


The TSOP37... series are miniaturized SMD IR receiver modules for infrared remote control systems. A PIN diode and a preamplifier are assembled on a PCB, the epoxy package contains an IR filter.

The demodulated output signal can be directly connected to a microprocessor for decoding.

The TSOP374.. series devices are optimized to suppress almost all spurious pulses from energy saving lamps like CFLs. The AGC4 used in the TSOP374.. may suppress some data signals. The TSOP372.. series are provided primarily for compatibility with old AGC2 designs. New designs should prefer the TSOP374.. series containing the newer AGC4.

These components have not been qualified according to automotive specifications.








### **BLOCK DIAGRAM**




Fig. 1 - Output Function





Fig. 2 - Output Pulse Width vs. Irradiance






Fig. 4 - Output Pulse Diagram




Fig. 5 - Frequency Dependance of Responsivity




Fig. 6 - Sensitivity in Bright Ambient




Fig. 7 - Sensitivity vs. Supply Voltage Disturbances




Fig. 8 - Max. Envelope Duty Cycle vs. Burst Length




Fig. 9 - Sensitivity vs. Ambient Temperature




Fig. 10 - Relative Spectral Sensitivity vs. Wavelength




Fig. 11 - Directivity




Fig. 12 - Sensitivity vs. Supply Voltage

#### SUITABLE DATA FORMAT

The TSOP372.., TSOP374.. series is designed to suppress spurious output pulses due to noise or disturbance signals. The devices can distinguish data signals from noise due to differences in frequency, burst length, and envelope duty cycle. The data signal should be close to the device's band-pass center frequency (e.g. 38 kHz) and fulfill the conditions in the table below.

When a data signal is applied to the TSOP372.., TSOP374.. in the presence of a disturbance, the sensitivity of the receiver is automatically reduced by the AGC to insure that no spurious pulses are present at the receiver's output. Some examples which are suppressed are:

- DC light (e.g. from tungsten bulbs sunlight)
- Continuous signals at any frequency




Fig. 13 - IR Signal from Fluorescent Lamp with Low Modulation




Fig. 14 - IR Signal from Fluorescent Lamp with High Modulation

- Strongly or weakly modulated patterns from fluorescent lamps with electronic ballasts (see fig. 13 or fig. 14)





Proposed pad layout from component side (dim. for reference only)







### **ASSEMBLY INSTRUCTIONS**

#### **Reflow Soldering**

- Reflow soldering must be done within 168 h while stored under a max. temperature of 30 °C, 60 % RH after opening the dry pack envelope
- Set the furnace temperatures for pre-heating and heating in accordance with the reflow temperature profile as shown in the diagram. Exercise extreme care to keep the maximum temperature below 260 °C. The temperature shown in the profile means the temperature at the device surface. Since there is a temperature difference between the component and the circuit board, it should be verified that the temperature of the device is accurately being measured
- Handling after reflow should be done only after the work surface has been cooled off





#### **DRY PACKING**

The reel is packed in an anti-humidity bag to protect the devices from absorbing moisture during transportation and storage.



#### **FINAL PACKING**

The sealed reel is packed into a cardboard box. A secondary cardboard box is used for shipping purposes.

#### **RECOMMENDED METHOD OF STORAGE**

Dry box storage is recommended as soon as the aluminum bag has been opened to prevent moisture absorption. The following conditions should be observed, if dry boxes are not available:

- Storage temperature 10 °C to 30 °C
- Storage humidity  $\leq$  60 % RH max.


After more than 168 h under these conditions moisture content will be too high for reflow soldering.

In case of moisture absorption, the devices will recover to the former condition by drying under the following condition: 192 h at 40 °C + 5 °C / - 0 °C and < 5 % RH (dry air / nitrogen) or

96 h at 60  $^{\circ}\text{C}$  + 5  $^{\circ}\text{C}$  and < 5 % RH for all device containers or

24 h at 125 °C + 5 °C not suitable for reel or tubes.
