






Fig.1 Power Dissipation Derating Curve





Fig.2 Maximum Safe Operating Area







Fig.4 Single Pulse Maxmum Power dissipation







Fig.7 Breakdown Voltage

Drain - Source Breakdown Voltage : -V_{(BR)DSS} [V]




Fig.8 Typical Transfer Characteristics





Fig.10 Transconductance vs. Drain Current






Fig.19 Switching Characteristics







Fig.20 Dynamic Input Characteristics

Fig.1-1 Switching Time Measurement Circuit




Fig.2-1 Gate Charge Measurement Circuit






Fig.1-2 Switching Waveforms


