




TEST CIRCUIT 2 SWITCHING TIME

TYPICAL CHARACTERISTICS (TA = 25°C)






TRANSIENT THERMAL RESISTANCE vs. PULSE WIDTH
























RDS(ση) - Drain to Source On-state Resistance - mΩ
















PACKAGE DRAWING (Unit: mm)
