
Forward Current vs. Collector Dissipation Temperature Rating






Light Current vs. Collector–Emitter Voltage Characteristics (Typical) Relative Light Current vs. Ambient Temperature Characteristics




Response Time vs. Load Resistance Characteristics (Typical)





Sensing Position Characteristics (Typical)




Light Current vs. Forward Current Characteristics (Typical)




Forward current I_F (mA)
