


Standard Bins for LO566TYL4-70G-A1 ($I_F = 20 \text{ mA}$)







- 1. All ranks will be included per delivery; rank ratio will be based on the dice distribution.






FIG.2 REVERSE CURRENT VS.

H-H: 70°




Mechanical Dimensions


Users should be cautioned not to stare at the light of this LED product. The bright light can damage the eye.
