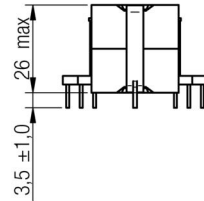

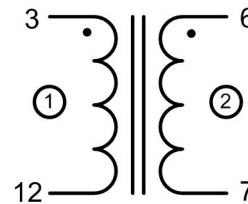

General:

All recommendations according to the general technical specifications of the data-sheet have to be complied with.

If the product is potted in customer applications, the potting material might shrink during and after hardening. After the potting material is cured, the core, wire and termination of the product have to be checked if any reduced electrical or mechanical functions or destructions have occurred.

Washing varnish agent that is used during the production to clean the application might damage or change the characteristics of the wire insulation, the marking or the plating. The washing varnish agent could have a negative effect on the long turn function of the product.



Direct mechanical impact to the product shall be prevented as the ferrite material of the core could flake or in the worst case it could break.

Product specific:

Follow all instructions mentioned in the datasheet, especially:

- The solder profile has to be complied with according to the technical wave soldering specification, otherwise no warranty will be sustained.
- All products are supposed to be used before the end of the period of 12 months based on the product date-code, if not a 100% solderability can't be warranted.
- Violation of the technical product specifications such as exceeding the nominal rated current will result in the loss of warranty.
- Due to heavy weight of the component, strong forces and high accelerations might have the effect to damage the electrical connection or to harm the circuit board and will result in the loss of warranty.


