















Drain Source Breakdown vs. Junction Temperature




THERMAL RATINGS (T_A = 25 °C, unless otherwise noted)





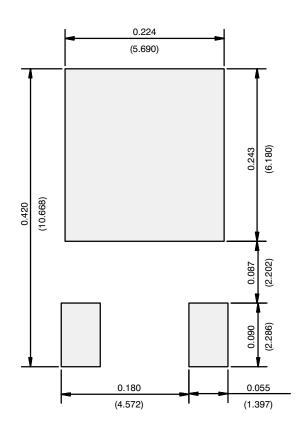
