





#### **Application Note:**

a) With the VESD05A6-HAF 6 different signal or data lines can be clamped to ground. Due to the different clamping levels in forward and reverse direction the VESD05A6-HAF clamping behavior is <u>Bi</u>directional and <u>Asymmetrical</u> (BiAs).



b) If symmetrical clamping behaviour is required the **VESD05A6-HAF** can also be used as a <u>**Bi**</u>directional <u>**Sy**</u>mmetrical protection device protecting up to 5 lines. In this case pin 7 must not be connected.








Figure 2. 8/20 µs Peak Pulse Current Wave Form acc. IEC 61000-4-5




Figure 3. Typical Capacitance  $C_D$  vs. Reverse Voltage  $V_R$ 




Figure 4. Typical Forward Current  $\rm I_F$  vs. Forward Voltage  $\rm V_F$ 




Figure 5. Typical Reverse Voltage V<sub>R</sub> vs. Reverse Current I<sub>R</sub>




Figure 6. Typical Clamping Voltage vs. Peak Pulse Current IPP




Figure 7. Typical Clamping Performance on + 8 kV - ESD Events (acc. IEC 61000-4-2)




Figure 8. Typical Clamping Performance on - 8 kV - ESD Events (acc. IEC 61000-4-2)





Figure 9. Typical max. Clamping Voltage at ESD Contact Discharge (acc. IEC 61000-4-2)
