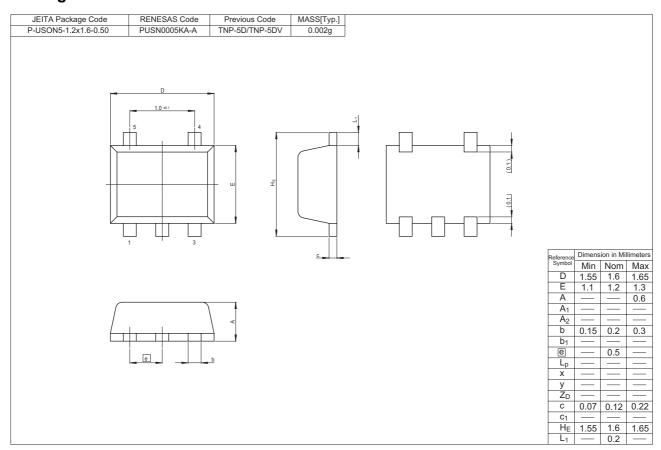
Test Circuit
