



## •Electrical characteristic curves (T<sub>a</sub> = 25°C)



## Fig.3 DC Current Gain vs. Collector Current

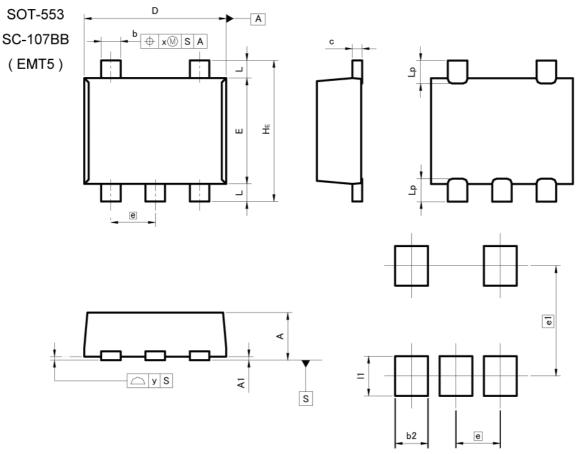
Fig.4 Collector-Emitter Saturation Voltage vs. Collector Current




